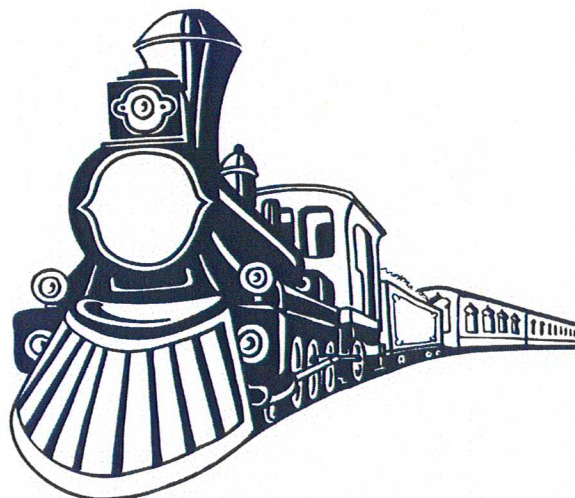

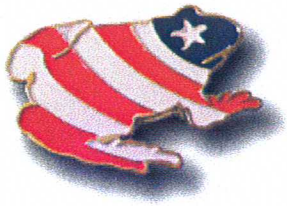

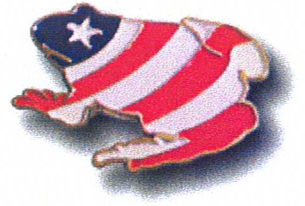

Where does the time go? I cannot believe November is almost over! My mom always said the older you get the faster time goes and she wasn't kidding.

Fall Conference is over and in spite of a few snafus, it went well. Special thanks to the many people that worked hard to make it a success. It was wonderful to have Past Department Presidents Jean Mahoney and Alma Zeller in attendance at Fall Conference. They both looked great!

Some questions were raised during Fall Conference that need addressing.

There is no official uniform of the American Legion Auxiliary. Blue pants or skirts are not required. Black is perfectly acceptable. In fact, Peggy's colors this year are Red & Black! Unless a Unit's governing documents dictate what a member can wear, then no member can tell another what to wear. Short shorts and jeans are discouraged from Department meetings; however, we are grateful to those that attend.

A post cannot demand anything of the unit associated with it. With that being said, it is a good practice to have a good working

relationship with your post, so always accommodate them when you can.

Membership Questions . . . We do not have a "go live" date from National yet. Test Units are now able to add new members to their Unit. If you are not set-up as a test unit, return the form mailed to each unit regarding information needed.

If you are currently a test unit and have not returned the form with your voided check, you will be turned off as a test unit.

If the unit does not want to go live, you do not have to. You will continue to process membership as you do right now. I would like to have the opportunity to discuss this with your Unit, however, to determine the reason you do not want to go live.

Girls State . . . the registration paperwork has been mailed to all units. The fee to register a girl for Girls State is \$350 per action on the Convention floor. Make sure all potential attendees are aware that no religious accommodations will be made for them at Girls State by action of the Convention Body. Deadline for registration is

February 1, 2013 or 300 delegates, which ever comes first.

Remember: to be qualified for participating in Girls State, the unit must be charter strength (10 Senior members paid) and all obligations must be paid.

IRS 990N . . . all units should have completed the 2011 990 N by now and copy of acceptance notice should be on file at Department. Corporations get renewed from January 1 – May 1, 2013.

It is with deep sadness . . . that we report the death of Charles Teasley, husband of Past Department President Linda Teasley. Charles passed on Veterans Day following a long illness. A memorial service will be held at a later date. In the mean time however, messages of sympathy can be mailed to Linda at: 97 Hardee St, LaBelle, FL 33935.

Past Fourth District President, Terry Lord, recently passed away. We have not received any information regarding family.

Department Headquarters . . . will close at noon on Wednesday, November 21 and remain closed until Monday, November 26th for the Thanksgiving Holiday.

Then we attended the Hospice Memorial Service, which was very inspirational. We had time to get in a few games of bingo (No luck) at Post 57 before calling it a night. The next morning Elaine and I met at the Robert H. Jenkins Domiciliary and toured that facility.

The train headed south, where I met Rita McLaughlin at the VA Medical Center in Gainesville. After touring the hospital and seeing where the new Fisher House was being built, we visited about needs and concerns. VOLUNTEERS!

I traveled to Orlando on November 1st, where Mary Feeley had arranged for Fred Holmes to give the tour of that VA facility. What did I hear? VOLUNTEERS!

Every VA Medical Center that I have visited so far can use lap robes, ditty bags and volunteers.

There are two types of volunteers: Regular, which requires training and 20 hours of service per week. Occasional, which requires no training and whatever time you can give. Contact the representative at the VA Medical Center closest to you to see what you can do for our veterans. All representatives are listed in the Unit Guide.

Remember the Gainesville Fisher House Walk of Courage. To date there has been 3 pavers and 9 bricks purchased. All from units, except for Holly Hill 120 Post, SAL and Riders. 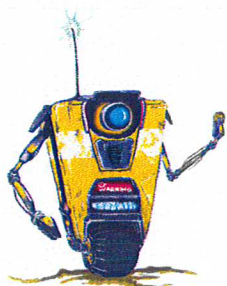

HONORING SERVICEWOMEN:

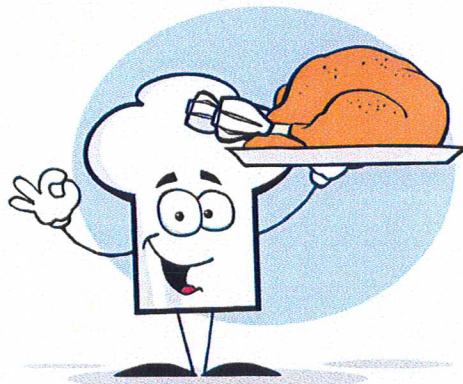
The Past Presidents Parley will continue to recognize the military service of active duty personal representing each branch of service this year.

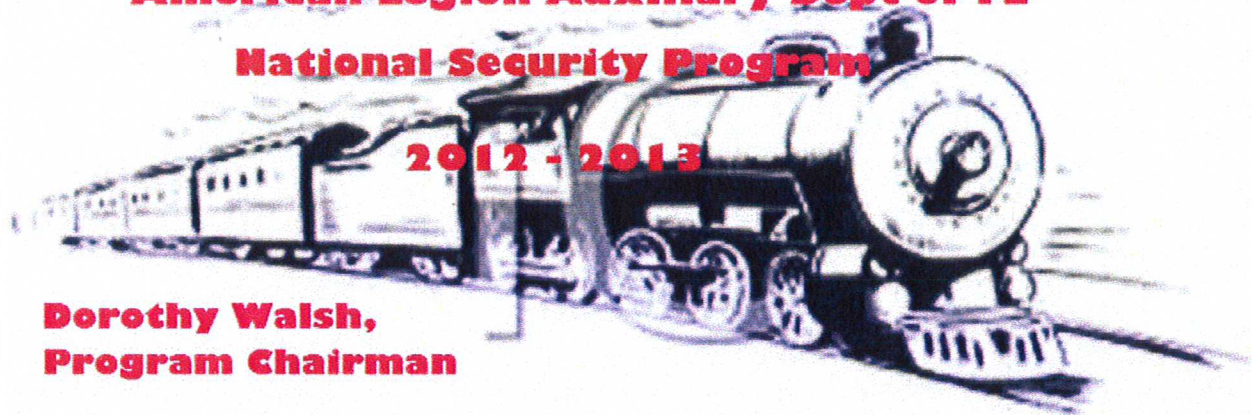
