## Constitution \& ByLaws

During the 2013 American Legion Auxiliary National Convention in Houston, Texas, delegates voted on updating the National Constitution and Bylaws and Standing Rules. Sections of the C\&BL that were frequently modified were moved to Standing Rules. There are several Units that do not have Standing Rules at present. In the next few months we will be working on changing the Department's C\&BL and working on instructing and helping the Units to change their C\&BL to be in compliance with National. This will be a work in progress for all of us.

The need for these changes are:

1. To eliminate the need to amend the bylaws to accommodate procedural, process, or detailed rule changes
2. To achieve the goal of amending the bylaws only every decade by streamlining the governing documents

Bylaws should not be amended more frequently than every 10-15 years. The ALA 990 reports to the IRS when bylaws have been changed. The IRS views organizations that amend their bylaws frequently as unstable, which in turn can trigger an IRS audit. This is now happening to other nonprofits reporting frequent bylaws changes.

Constitution - The organization's incorporation statement; the reason the ALA exists. It should rarely, if ever, change.

Bylaws - An organization's core governance structure, roles and purposes. Bylaws are the ALA's "bones" - fixed only when broken or critical to continue the purpose of the organization, not frequently.

Standing Rules - Requirements for how the organization achieves good governance. Details about the ALA's structure, i.e., committee make-up, recurring governance events; its "Skin" - has flexibility to be changed to keep up with current times, as often as desired. Changes to Standing Rules are not reported to IRS, eliminating an IRS audit red flag.

We are going to attempt to put an article in the "Crusin News" every month with one or two of the changes in order to make it a little easier to understand, and not to inundate everyone. Hopefully there will be a C\&BL breakout session at Fall Conference.

The first change I would like to address is under membership eligibility. There is no change to the eligibility, but to the wording. The wording for eligibility currently uses "granddaughters, great-granddaughters, and grandmothers". This wording has been changed to "descendents". This means that the lineage of descendents goes on forever. Counsel General recommended the wording, which is how the Sons bylaws now read.

The second change is Dues under Bylaws -- Article III. The wording should be - Membership dues shall be paid annually or for life, and shall include the Department and National per capita.

The amount of Dues for Units will now be in the Standing Rules.

Child Welfare Foundation. Join the "Children's First" gift club.
There are three (3) children's hospitals in Florida. The hospital in Pensacola is now called New Horizons of Northwest Florida. They are in need of defibulators, bath towels, wash cloths, bibs and of course donations.

All Children's Hospital in St. Petersburg and The Mailman Center for Child Development in Miami also need your donations. All Children's Hospital in St. Pete is doing a toy drive for their Winter Wonderland in December. More info to follow when I receive their wish list.

## Ingredients:

4 cups miniature marshmallows
1/4 cup butter, cubed
6 cups crisp rice cereal
12 oval cream-filled chocolate sandwich cookies

3. Position cereal squares on a large serving tray. With 2 tablespoons frosting, form a circle on each cereal square; top each with a decorated cookie. Sprinkle reserved crumbs around tombstones; add Halloween sprinkles. Yield: 12 servings.

## Red Cross - HOLIDAY MAIL FOR HEROES

The American Red Cross organizes this national initiative to collect and distribute holiday cards for service members and veterans. There are several ways to be part of the Holiday Mail for Heroes program. Send cards on your own, have every member bring them to a Unit meeting, host a card signing party or card making party. Remember to involve your Juniors, this is a great project for them.

Here are a few guidelines to help you on your way:
Every card received will be screened for hazardous materials by Pitney Bowes and then reviewed by Red Cross volunteers.

Please observe the following guidelines to ensure a quick reviewing process:

- Ensure that all cards are signed.
- Each card should include a hand written sentiment. Use generic salutations such as
"Dear Service Member." Cards addressed to specific individuals can't be delivered through this program.
- Only cards are being accepted. Do not send or include letters.
- Do not include email or home addresses on the cards: the program is not meant to foster pen pal relationships.
- Do not include inserts of any kind, including photos: these items will be removed during the reviewing process.
- Please refrain from choosing cards with glitter or using loose glitter as it can aggravate health issues of ill and injured warriors.
- If you are mailing a large quantity of cards, please bundle them and place them in large mailing envelopes or flat rate postal shipping boxes. Each card does not need its own envelope, as envelopes will be removed from all cards before distribution.

$>$ Hygiene items (specific for men and women), tooth brush, tooth paste, deodorant, razor, sewing kits, soap, hand cream, powder, denture adhesive, shampoo, hand towels

## Tame That Grey Hair!!

Recently honored for her 90 years of continuous membership and long service to the American Legion Auxiliary by Department President Gerrie Bailey, Unit 27 member Valecia Deas became a junior member upon birth. Her father, an American Legion member active in the early days of Ocala Post 27 and an FBI agent involved in surveiling the Ma Barker family home to identify when all family members were present, proudly signed her up.

Valecia was a Little Miss Poppy as a child and has volunteered every year since during Poppy Days. Valecia recalls growing up on her grandfather's 480 acre farm near Reddick, riding horses and being quite independent.

In high school the outspoken redhead was the only girl to own a car, driving in to Ocala with her best friends for dances and the cinema at the recently refurbished downtown Ocala Theatre. During these outings, she met her husband-to-be, Nole Deas, who climbed over seats to sit next to her at the movies. They married shortly before he enlisted during World War II, and she worked at the Marion County Courthouse, then located on the downtown square.

When he returned, he and other returning veterans joined the American Legion and became active in its many civic projects, serving in many leadership capacities. The young couple had a son, Nole Jr., and both worked for more than 30 years in Ocala. Valecia retired as head accountant for Skyline Industries, a two-state manufacturer of mobile and manufactured homes.

Remembering when Auxiliary members attended meetings wearing dresses, gloves and hats, she and Nole participated in Post 27 and its Auxiliary when they had several hundred members and meetings included entire families enjoying catered dinners and barbecues. Meetings were more formal, and belonging to the American Legion was quite prestigious. Robert's Rules of Order were carefully observed at all meetings. "But the projects such as Boys and Girls State were the same, and the Auxiliary still does a lot of good for veterans and the community," she says.

She was particularly active in chairing the Unit's Membership and Girls State activities and served as treasurer for more years than she can remember. Valecia still enjoys volunteering at the Ocala Veterans Clinic, distributing snacks and water on a monthly basis, and distributing poppies. "Veterans were considered real heroes and given a lot of respect back then and should be treated that way still."

Nole and Valecia were among the World War II veterans who raised money to design and build the spacious American Legion Building at Tuscawilla Park in Ocala, and thirty years later Nole was among veterans who led the movement to design and build Ocala's remarkable Veterans Park in cooperation with City of Ocala leaders. Among Valecia's fondest memories is traveling statewide and to Washington, D.C. with Nole when he served as Florida Legion Commander.

Even after Nole's death four years ago, and despite failing eyesight, Valecia faithfully attends patriotic events at the Park and local and District meetings of the Auxiliary. "I don't know many of the people at our meetings any more," she comments, "but they all seem to know me!" She looks forward to Poppy Days and attending Veterans Day events again this year.
