




"LIGHTING THE WAY FOR OUR VETERANS"

In the beginning of the year and when it ends;


When we are weary and in the need of strength;

From the desk of Congressman Yoho

Dear Friends.

Before heading home to the district, for the August work period, I voted for one of the most significant veterans' bills passed through the house this year, the Veterans' Access Choice and Accountability Act of 2014 – H.R. 3230.

The unfortunate news of numerous scandals within the Veterans' Administration (VA) over the past couple of months - specifically the Veterans' Health Administration (VHA)- has shone an ugly light on a system that is in need of reform. The Veterans' Access Choice and Accountability Act, which was signed into law by the President on August 7, 2014, will begin these much needed reforms.

The biggest problem area uncovered in the VA/VHA system were the prolonged wait times veterans had to endure just to see a doctor. For all the sacrifices these brave men and women have endured, this was, and is, unacceptable. H.R. 3230 provides immediate relief to veterans who have been waiting to receive care for extended periods of time. This portion of the bill applies to future veterans as well who experience delays while the VHA/VA makes the necessary programmatic and supervisory changes that will reduce the backlog and prevent future ones.

In addition to long wait times, the underlying issues are many, incompetency, ill-prepared facilities, and staff that are not held accountable for their poor performance. All require an overhaul of the approach and process the VA/VHA uses to treat veterans. This bill increases oversight, allows for the Secretary to hold senior executives accountable for poor performances by revising the review process. In addition, it removed the inclusion of veteran wait-time as a metric for performance. The cost of taking care of America's veterans should never be a limiting factor in regards to their access, treatment, and care.

H.R. 3230 includes numerous provisions from multiple bills I have cosponsored or supported during my time in Congress. Many of the bills received bipartisan support in the House, but no action was taken in the Senate. Since the bill was based on common ground for House and Senate, this was Congresses best opportunity to address many issues in the Veterans' Administration (VA) that have not been reconciled in years.

I am honored to representative over 100,000 veterans in the greatest congressional district in Florida. I am and always will be committed to making sure they receive quality care as quickly as possible. They stood up for us, they deserve a government that stands for them.
