# President's Photo Gallery























The American Legion Auxiliary Department of Florida is "Flush with American Pride". Wow March already. It seems we are just getting started and it's time to begin wrapping things up.

Great job to our members and community on promoting American pride by displaying our flag on patriotic holidays. But are we displaying it properly? Our national website alaforveterans.org has a list of ways that we may be disrespecting the flag without even thinking about it. Here are a few items from that list that we should be aware of. The flag must be hoisted briskly and lowered ceremoniously. It should be saluted as it is hoisted or lowered and never touch anything beneath it. It should be flown sun up to sun down unless illuminated during darkness. And it should not be displayed on days of bad weather. The flag should never be used as drapery, decoration or apparel. And should be burned in a dignified manner when rendered unusable

Let's talk about flag disposal. This summer a past Department President witnessed a flag disposal ceremony where those participating in the ceremony were cutting down the lines of the red and white stripes of the flag to render it unusable. It brought tears to her eyes. Because of the synthetic materials some of the flags are made of these days. Some are arguing they could be considered toxic to the environment and should not be burned. After cutting them up, the remnants are sent to a recycling center. While some posts have taken to this method of disposal, the American Legion Auxiliary follows the official position of the American Legion. They have set Flag Day June 14th as the day to dispose of unusable flags preferably by burning. I'm sure there's more to come on this.

The latest action on the Flag amendment proposal is this. HJR 61 was set forth in the House of Representatives by Rep Steve Womack on 02/08/2017 during the 115th congress. HJR 61 reads "Proposing an amendment to the Constitution of the United States giving Congress power to prohibit the physical desecration of the flag of the United States." This bill has been sent to the house judiciary subcommittee on the constitution and civil justice for study.

Meanwhile, the United States Supreme Court has repeatedly ruled that flag burning is a freedom of speech first amendment right. The amendment to protect the flag against desecration continues to be one of the American Legion's top legislative priorities.

Finally, this a reminder to watch those deadlines for the Americanism Essay contest. Your unit sponsored winners must reach this chairman by April 1st. Also remember the Essay Cover sheets. Without them we can't forward the winning essays to National.

Just a few housekeeping items as we are rounding the bend to our Department Convention. I know it seems like along way off, but it will be here before you know

The first thing is, if your Unit Constitution and Bylaws have not been updated since 2014, your Unit is out of Compliance. They need to be revised to conform to the Department of Florida's changes ASAP. Please send two (2) signed copies to me (Linda Knoblach-Harkness 5916 Starlite Lane, Milton, Florida 32570) by April 1. This will allow me time to review them and make sure your unit has time to make corrections/changes. If you use the template at <a href="https://alafl.org/programs/">https://alafl.org/programs/</a> constitution-bylaws/ the changes are part of that that document.

If your Unit wants to change the dues, it is too late for 2019, however, not for 2020. This change will be in your Standing Rules. I will need to receive two (2) signed copies of the amended Standing Rules along with your current "already approved" Constitution and Bylaws by March 15, 2019. Once the Standing Rules have been approved, the unit will need to submit the Unit Dues Information Form 2020 found at https://alafl. org/quicklinks/forms-resources/ under unit forms no later than April 15, 2019. If the unit fails to meet this deadline, a \$30 fee will be assessed to make the change. Please keep in mind that Department must convey the dues increase to National for the purpose of giving National time to make the changes to the mail-out reminders and to the website for those members paying their dues online.

The second item is, if your Unit would like to submit a Resolution to the Department of Florida, it is due six (6) weeks prior to convention which is no later than

May 16, 2019. There is a guide on how to

write a resolution at www.legion.org/resolutions or https://www.alaforveterans.org search for Department Operations Guide. It's in Chapter 12. More information about submitting Resolutions to Department of Florida are in the Unit Guide on page 35.

And number 3 is REPORTING. Yes, Constitution and Bylaws does submit an end-of-year report. There is a guideline for your reports at https://alafl.org/programs/ constitution-bylaws/ in the Program Action Plan as well as at <a href="https://alafl.org/quicklinks/forms-resources/">https://alafl.org/quicklinks/forms-resources/</a> under 2018-2019 Reporting. Units need to have the reports to their District Chairman by April 1st. District Chairmen need to have them to me no later than April 15th. You can mail them to me or email them. Please ladies, let's get 100% reporting.

As always ladies, I'm here to help in any way I can. Please feel free to reach out to me with any questions.

The Department of Florida has a form on its website that is called the Donation Remittance Form. This donation form lists programs, and projects, where Units can send donations. One such charity, under Youth Programs, is CAMP BOGGY CREEK. I would like to highlight a wonderful organization that is located in Eustis, Florida. I had the honor of visiting Camp Boggy Creek in February. The experience forever changed me and I would like you to know more about it. This information, to follow, is directly from their website address of www.boggycreek. org.

Camp Boggy Creek was founded in 1996 by Paul Newman and General H. Norman Schwarzkopf, with one simple premise in mind, that every child, no matter their illness, could experience the transformational spirit and friendships that go hand in hand with camp.

With unobtrusive expert medical care, it was

their dream that Camp would provide seriously ill children with a fun-filled experience defined by compassion, laughter, and acceptance.

Since 1996, Camp Boggy Creek has made it possible for children with serious illnesses to enjoy a camp experience in a safe, medically sound environment. Located just a short drive from Orlando, Florida, the 232-acre camp serves children ages 7-16 who have been diagnosed with chronic or life-threatening conditions.

Camp Boggy Creek never charges campers to attend and never asks them to contribute anything other than a positive, playful attitude.

As a year-round retreat, Camp Boggy Creek is able to serve thousands of campers and their families through activity-packed weekly and weekend camp programs. The camp offers children the chance to catch their first fish, go horseback riding or climb our ropes tower, all while making new friends.

Beyond boundless fun, Camp Boggy Creek provides fellowship. Children can spend time with others who are just like them and share their



life-experiences, which serves as a reminder that they are not alone.

Visiting this camp took us back in time to when we went to camp as children! The grounds



medical center, dining hall, swim center, stable and nature barn, sports & recreation center, arts & crafts center and theater. All the buildings are wooden structures designed like a summer camp.

You can actually picture these children fishing on the dock catching their first fish, smiling bigger than ever as they ride a horse, highfiving each other because they hit the target with their arrows! Can you image how thrilling it must be, for them, to steer a canoe or reach the top of the rock-climbing wall?

Any child, medically treated in Florida, can apply. Over 3,000 children attend the camp each year. Specifically designed, the camping sessions group children with similar illnesses together. Instead of always being different, these "campers" have something in common. Camp Boggy Creek welcomes children diagnosed in the following illness groups:

- Arthritis / Rheumatic
- Asthma (severe)
- Cancer
- Craniofacial
- Diabetes
- Epilepsy
- Gastrointestinal
- Hemophilia / Bleeding Disorders
- Immune Deficiency
- Kidney
- Sickle Cell
- Spina Bifida
- Transplants
- Disorders Requiring Ventilator Assistance

HELP?? Units, and

individuals, can make monetary donations, towels, bedding, or arts and craft supplies. Each child receives a blanket and a Boggy Bear when they get to camp. These two items can go home with them to remember their time at camp. Units can sew blankets for the children or make Boggy Bears. Sharon Couture, Foundation & Corporate Relations Officer, was our tour guide. She told us that people make the Boggy Bears, sewing them up, but leave one opening. The volunteers will then throw "stuffing parties" and stuff all the bears! What a great project for your Senior AND Junior members! The pattern for the Boggy Bear is on the Department website under Children & Youth.

You can also volunteer at the camp. It does not matter if it is a few hours or a few days! All the Doctors and Nurses, are volunteers. The campers address Dr. Rick Thomas as "Dr. Rick", and Nurse Sherry Smith as "Nurse Sherry"!

Please visit their website to learn more about this wonderful organization and the opportunities for us to assist them in enriching the lives of children.

- When submitting numerous years for a member, each year will require a separate recap sheet.


#### **Poppies**

Bryan was the closest so he told his brother he would go, it had stopped raining but the roof was wet Bryan slipped and fell of the roof he hit something on the way and he landed on his head. He was rushed to the hospital but did not survive, however Bryan led a clean life he did not smoke, drink, or do drugs. They were able to donate all of his organs, as he had wanted.



Bryan was only 35 years old and his youngest child a son was only 5 months old. This year at the Donate




**Unit 273:** General Meeting February 4, 2019. Members came streaming in until it was a full house with standing room only. So excellent 273 is getting it done for the veterans!
