# Cavalcade of Memories

Ladies, REMEMBER we our celebrating our 100 year Anniversary. So, what better way to celebrate this year by showcasing treasured keepsakes and memorabilia by telling our story of the history of the American Legion Auxiliary. We need to be proud and honored to those who have made significant contributions to our organization. History is something we cannot change but learn from other's knowledge and contributions to move forward to improve our organization.

National is preparing to celebrate our 100 year Anniversary for the American Legion Family as founded in 1919. So, we should be preparing as well, to show what we do for our Veterans, Military Families, Community, and Children and Youth. As we, the American Legion Auxiliary "In the Spirit of Service, Not Self, is our mission to support the American Legion to honor the sacrifice of those who serve by enhancing the lives of our veterans, military, and their families, both at home and abroad".

In keeping with President Michelle's theme "We're All In!" include the American Legion Family to participate in activities for 2018-2019.

#### A bit of History:

About 1,000 officers and enlisted men attended the Paris Caucus in March 1919. They adopted a temporary constitution and the Name The American Legion. The group also elected an executive committee to complete the organization's work. It considered each soldier of the AEF member of the Legion executive committee named a subcommittee to organize veterans at home in the United States. In May 1919, the legion held a second organizing caucus in St Louis. It completed the constitution and made plans for a permanent organization, setting up a temporary headquarters in New York City and beginning its relief, employment and Americanism programs.

Congress granted the Legion a national charter in September 1919. The first national convention convened in Minneapolis on November 10-20, 1919, adopting a permanent constitution and electing officers to head the organization. Delegates also voted to locate Legion's national headquarters in Indianapolis, Indiana. The Legion continues to support the four pillars of service and advocacy upon which it was founded. Veterans Affairs and Rehabilitation, National Security, Americanism, and Children and Youth.

After its formation in 1919, several women's organizations wanted to become the official affiliate of the Legion. A committee decided to create a new organization made up of the women most closely associated with the men of the Legion. During The American Legion first convention November 10, 1919, members and officials founded the American Legion Auxiliary. In less than a year

#### ALA 2019 Girls State Important Information: To all Unit and District Girls State Chairman 2019 Session: June 5 – June 13

#### Unit Girls State Chairman: Preparing your Delegates and Alternates:

Please remind all the delegates and alternates that they MUST attend an ALA Girls State Orientation with a parent or guardian. If they do not complete an Orientation, they are not eligible to attend ALA FL Girl State.

During this time before the ALA Fl Girls State session, you need to keep in close contact with your delegates, alternates and parents. Please keep reminding delegates and alternates that they must attend a Girls State Orientation. Be prepared to receive additional or up-dated material from your District ALA FL Girls State Chairman.

You are requested by the Director to discuss the dress code with the delegates as often as possible. Shorts are to be mid-thigh length. If shorts are too short, the delegate will be asked to change. New shoes are not recommended. They always result in blisters. We walk an average of 6 miles a day. Heels of any height are not permitted.

#### **District Girls State Chairman: Orientation:**

There is an Orientation in every District, if your delegate or alternate cannot attend your district, please help them find another orientation to attend.

Make sure that they have attended in the other district. Orientation schedules are on line at alafl.org.

**Orientation Sign-in sheets** (emailed to the District Girls State Chairman by Department Chairman, Marge Reed on March 6, 2019) please ask delegates, alternate and parents to print clearly the information requested.

As reminder, each delegate or alternate must have a parent or guardian there for the entire orientation session.



Greetings from Department Headquarters. This month we are going to focus on the use of poppy proceeds and poppy orders. When submitting a poppy proceeds form, you will need the following information:

- Total cost of poppies
- Total expenses with receipts (must submit receipts to Department Headquarters)
- Total remaining
- 25% of remaining balance to be submitted to Department

Below is an email from National Program Manager Chrystal Daulton on expenses acceptable for deduction:

The unit may deduct anything used to make the poppy items they are distributing such as the cost for the poppy kit, ingredients for poppy cookies, materials for crocheted poppies, etc.

The Legion set forth five criteria for the use of Poppy funds. The first four criteria are centered around medical needs/rehabilitation and welfare. Unfortunately, the cost in planning/ executing a party does not fall in line with those concepts with the exception of item 5, which I covered above.

- 1. The rehabilitation of veterans honorably discharged from the United States Armed Forces after April 6, 1917.
- 2. The welfare of the families of veterans of the above named period.
- 3. The rehabilitation of hospitalized military

service personnel returning home and awaiting discharge who require treatment in service hospitals.

- 4. The welfare of veterans, active military personnel, and the families of veterans and active military personnel of the above named period where financial and medical need is evident.
- 5. For the purpose of poppy kits and supplies used to make symbolic poppies and poppy items that will be distributed for donations to the Poppy Fund.

The only additional item mentioned in the poppy guide is on page 11 as follows:

Therefore scholarships (or funds to aid with higher education) would have to be for a veteran or their immediate family member who demonstrates an immediate financial need. For example, if a unit is met with a situation in which a student meets Poppy Fund eligibility and demonstrates a financial need (e.g., delay in delivery of post 9/11 GI Bill funding impacting their academics), the unit may decide to use Poppy Funds to assist the student.

If units wish to create their own scholarship(s) as a way to use their Poppy Funds, please keep in mind the criteria that must be met by recipients in order to stay within the guidelines for proper usage.

When ordering poppies per the Department Unit Guide page 94, all poppies must be ordered through Department Headquarters. Units may not resell Poppies to any organization



outside of the American Legion Auxiliary. All orders must be to Department 90 days prior to Poppy Day.

Poppy Distribution in the Department of Florida shall be limited to two times during the Auxiliary year. The Memorial Day and Veteran's Day distribution is deemed to be the normal Poppy Distribution time; however, if another distribution date (whether temporary or permanent) is desired, permission must be granted by the Department President. Once a permanent distribution date is approved by the Department President, it stands as being approved until such time as another new distribution date is requested.

Department Headquarters has received an increase of poppy orders in the last year and we are working very hard to fill all the orders.

I hope this information is helpful.

Hello ladies. Thank you for welcoming me with open arms. There are a few items that have come up since the beginning of the year that need to be addressed.

**MCR Report:** With the report that went out for February 2019, I have changed the format. Negative balances will now show as parenthesis and can be used on a future membership transmittal being sent to Department. Positive balances must be remitted to Department immediately.

**Outstanding Invoices:** Just a reminder that invoices need to be paid in a timely manner. Starting in April, if you have an outstanding invoice, greater than 30 days you will be receiving a statement.

**Outstanding Checks:** If you have received a letter from me, regarding an outstanding check, please make sure that you are addressing this immediately. All checks issued from Department, and not cashed within 90 days will receive a letter from me. Please make sure that you are depositing/cashing these checks as soon as you get them.

**Sales Tax:** Who qualifies? Any nationally chartered or recognized veterans' organization and its auxiliaries (posts) that holds a current exemption from federal income tax under IRC 501(c)(4) or 501(c)(19). What is exempt? Purchases and leases of items or services by,

and rentals or leases of real property and living or sleeping

accommodations to, a qualified veterans' organization and its auxiliaries used in carrying on its customary veterans' organization activities. *Sales of food or drink by qualified veterans' organizations in connection with customary veterans' organization activities to members of qualified veterans' <u>organizations.</u> If your unit does not currently hold this exemption email me at <u>treasurer@alafl.org</u> and I will send you the instructions and form.* 

**Unit Checks:** When sending checks to Department, they will need two signatures.

**Poppy Proceeds Report:** This report will be reconciled when I receive it. The cost of the poppies purchased is the *total* cost (including shipping) paid to *Department. (As per the Constitution and ByLaws, all poppies must be purchased directly from Department.)*

### How can you recruit and involve Auxiliary Advocates?

#### National Veterans Museum and Memorial Chronicles Women in the Military

The National Veterans Memorial and Museum (NVMM), opened on Saturday, October 27, 2018, in Columbus, Ohio. The late Senator John Glenn was instrumental in bringing the NVMM to fruition. The museum received a national designation from Congress and President Donald Trump in January 2019.

National Veterans Museum and Memorial is a unique place, dedicated to telling the stories of veterans. The story telling is not separated by branch of service, conflict or gender of those who served. The story of women in service is incorporated into the museum's narrative. NVMM stitches all stories together through video interviews, audio recordings, touchscreens, handwritten letters and a time line. The video story-telling features 24 inspiring women veterans. A few of the stories are included below:

#### Bonnie Carroll, Air National Guard, 1982-2013, Iraq War

Bonnie served for 16 years as a transportation, logistics, and executive officer. She founded Tragedy Assistance Program for Survivors (TAPS) in 1994. President Obama awarded her the Presidential Medal of Freedom in recognition for her efforts to provide support to families of fallen service members through TAPS.

#### Jaspen Booth, Army, 2000-2018, Iraq War

Jaspen "Jas" Boothe joined the Army in 2000. In 2010, Jas founded "Final Salute," a nonprofit dedicated to serving homeless women veterans. Since then, "Final Salute" strives to assist the more than 50,000 homeless women veterans and children in over 30 states and territories.

#### Senator Tammy Duckworth:

Tammy served in the Illinois Army National Guard. In 2004, she deployed to Iraq as a helicopter pilot. She lost both her legs when her helicopter was shot down by Iraqi insurgents. She retired from the military in 2014, and has since represented Illinois in Congress, first in the House of Representatives from 2013 to 2017, and currently serves in the Senate.

**Deborah Sampson** disguised herself as a man and served 17 months in an elite unit of the Continental Army during the Revolutionary War.

National Veterans Museum and Memorial is the first and only national museum dedicated to the stories of veterans, from their enlistment or draft, to their reception upon coming home and life after discharge. The exhibits throughout the museum honor veterans and educate civilians. An education for the visitors on what it means to serve and perhaps to inspire a military career.

WOW! That is all I have to say about the 15th District Family. We have a member, Mary McColgan, from Unit 248, that has been working directly with the James A. Haley social workers to help house transitioning Homeless Veterans. This Program is called HUDVASH (Housing and Urban Development- Veterans Administration Supportive Housing). This program began just over 1 year ago when Mary started a food pantry through her Unit. This is a pantry that she has collected food items, personal care items, etc. for. She works directly with the Social Workers for the Veterans that run out of supplies before their monies become available. Items she collects include but are not limited to: Pasta, Pasta sauce, Rice, Peanut Butter, Jelly, Bags of black beans, lima beans, etc., Cereal, Condensed milk, Chef Boyardee canned pastas, Cup O' Soup type soups where you just add hot water, Canned hams, Tuna, Canned chicken, Protein Bars, Fruit Bars, Individually wrapped crackers and cheese or peanut butter, Cases of Water, Snack packages of tuna and crackers, Fruit cups etc. Personal Hygiene items such as: Toilet Paper, wet wipes, Diapers, Women Hygiene, Socks, etc. Please, please, please, if you are going to donate DO NOT SEND EXPIRED FOODS. We are collecting foods and items for our veterans, we are not your dumpster or trash service.

Mary was also responsible for working with the VA for several years to put together the Stand Down. After several years of the turn out getting smaller and smaller and the donations becoming larger and larger, the VA asked Mary to discontinue the Stand Down. With the Stand Down being discontinued they came to Mary to ask for donations to help house Veterans. These Veterans have been homeless and have now


been approved and placed into Housing. Mary started with collecting items and placing them in her Storage unit outside of her Post Home, however the donations became so immense that she purchased a storage unit down the road from her Post home. Once again, the donations kept pouring in and she found a building that is around 1,000 square feet. She now uses that building for storage of the furniture she receives as donations as well as the food pantry. Mary organizes directly with the social workers to obtain the information she needs in order to help get the veterans what is needed to make their house a home. Mary has been working directly with 15th district Legionnaires, Sons of the American Legion, and Legion Riders members to help pick up donations and deliver furniture to the Veterans who were just placed into a new home. Along with the furniture donations, Mary also coordinates donations for a starter basket. Now you ask what is a starter basket? Mary puts together a tall laundry basket with items necessary to start making their new house a home. Items include:

Mop, Broom Dust pan, Wash bucket with handle, Shower Curtain and hooks, Small bath mat for outside of shower/tub, Toilet Bowl Brush, Kitchen wash cloths, Can opener, Plastic plates, bowls, tumblers, Kitchen Utensils (spatula, slotted spoon, unslotted spoon), Bathroom towel and face cloth, Tall laundry basket, Silverware, Silverware Trays, Aluminum Foil. If you would like to donate, we ask that you please stay LIST SPECIFIC.

To date Mary has received enough donations to help house over 75 veterans. The furniture donations accepted are: Dressers, Tables with Chairs, Bed Frames (no mattresses), End tables,



TV stands, etc. However, if you have something you may think is needed you can always reach out to see if it is something that could be used towards this wonderful program. Mary really has gone ALL IN for this project and it is very heartwarming and touching to be able to say I have had the opportunity to work alongside and be mentored from someone with such a great big heart.
