President



Protocol

The National American Legion Auxiliary Constitution & Bylaws states, all American Legion Auxiliary meetings will be conducted using "Parliamentary Procedure" based on Robert's Rules of Order, Newly Revised.

So what is Parliamentary Procedure?

Parliamentary Procedure is a set of rules that exists to facilitate efficiently conducted meetings that protect the rights of members. It allows everyone to be heard and to make decisions without confusion.

The fundamental principles of Parliamentary Procedure are:

- 1. Fairness of process and courtesy for all.
- 2. Only one thing, speaker, motion, or action at a time.
- 3. The majority rules.
- 4. The minority must be heard.
- 5. Each proposition is entitled to a full and free debate.
- 6. The purpose is to facilitate action, not to obstruct it.

Why is Parliamentary Procedure Important?

Because it's a time tested method of conducting business at meetings and public gatherings. It can be adapted to fit the needs of any organization. Today, Robert's Rules of Order newly revised is the basic handbook of operation for the American Legion Auxiliary when conducting a meeting. So it is important that everyone know these basic rules!

Meetings, Motions and Members Rights!

American Legion Auxiliary meetings usually follow a fixed order of business. Below is a typical example:

- 1. Call to order.
- 2. Roll call of members present.
- 3. Reading of minutes of last meeting.
- 4. Officers' reports.
- 5. Committee reports.

- 6. Special orders --- Important business previously
- 7. esignated for consideration at this meeting.
- 8. Unfinished business.
- 9. New business.
- 10. Announcements.
- 11. Adjournment.

The method used by members to express themselves is in the form of moving motions. A motion is a proposal that the entire membership take action or a stand on an issue. Individual members can:


- 1. Call to order.
- 2. Second motions.
- 3. Debate motions.
- 4. Vote on motions.

How are Motions Presented?

A motion is a formal step to introduce a matter for consideration by a group. Generally, a motion should be phrased in a way to take action. The person making the motion is called the mover. Therefore when you make a motion you are moving the motion into action for this reason the mover states "I move to" or "I move that".

- 1. Obtaining the floor
 - a. Wait until the last speaker has finished.
 - b.Rise and address the Chairman by saying,
 "Madame Chairman, or Madame President."
 - c. Wait until the Chairman/ President recognizes you.
- 2. Make Your Motion
 - a. Speak in a clear and concise manner.
 - b.Always state a motion affirmatively. Say, "I move that we ..." rather than, "I move that we do not ..."
 - c. Avoid personalities and stay on your subject.
- 3. Wait for Someone to Second Your Motion
- 4. Another member will second your motion or the Chairman/ President will call for a second.
- 5. If there is no second to your motion it is lost.
- 6. The Chairman/ President States Your Motion
 - a. The Chairman/ President will say, "it has been





- b. The membership then either debates your motion, or may move directly to a vote.
- c. Once your motion is presented to the membership by the Chairman/ President it becomes "assembly property", and cannot be changed by you without the consent of the members.
- 7. Expanding on Your Motion (Discussion)
 - a. The time for you to speak in favor of your motion is at this point in time, rather than at the time you present it.
 - b.The mover is always allowed to speak first.
 - c. All comments and debate must be directed to the Chairman/ President.
 - d.Keep to the time limit for speaking that has been established.
 - e.The mover may speak again only after other speakers are finished, unless called upon by the Chairman/ President.
- 8. Putting the Question to the Membership
 - a. The Chairman / President asks, "Are you ready to vote on the question?"
 - b.If there is no more discussion, a vote is taken.

There are two other motions that are commonly used that relate to voting.

- 1. Motion to Table -- This motion is often used in the attempt to "kill" a motion. The option is always present, however, to "take from the table", for reconsideration by the membership.
- 2. Motion to Postpone Indefinitely -- This is often used as a means of parliamentary strategy and allows opponents of motion to test their strength without an actual vote being taken. Also, debate is once again open on the main motion.

Voting on a Motion:

The method of voting on any motion depends on the situation and the by-laws of policy of the organization. There are five methods used to vote, they are:

- 1.By Voice -- The Chairman asks those in favor to say, "aye", those opposed to say
- "no". Any member may move for an exact count.
- 2.By Roll Call -- Each member answers "yes" or "no" as her name is called. This method is used when a record of each person's vote is required.
- 3.By General Consent -- When a motion is not likely to be opposed, the Chairman says, "if there is no objection ..." The membership shows agreement by their silence, however if one member says, "I object," the item must be put to a vote.
- 4. By Division -- This is a slight verification of a voice vote. It does not require a count unless the chairman so desires. Members raise their hands or stand.
- 5. By Ballot -- Members write their vote on a slip of paper; this method is used when secrecy is desired.

It is the chair's duty to make the declaration of fact and to announce the result of the vote. She will either say, "The ayes have it and the motion carried or "The noes have it and the motion has failed". The chair also needs to tell the assembly what will happen as a result of the vote

Parliamentary Procedure is the best way to get things done at your meetings. But, it will only work if you use it properly.

- 1. Allow motions that are in order.
- 2. Have members obtain the floor properly.
- 3. Speak clearly and concisely.
- 4. Obey the rules of debate.

Most importantly, BE COURTEOUS to one another!

Many resources are available to our members, and the American Legion Auxiliary Unit Guide Book compiled by National is a good place to start. This book is available online at www.alaforveterans.org or through Emblem Sales Catalog for \$9.95. Please review National's Unit Guide Book, Department's Unit Guide, and Roberts Rules of Order Revised. When in doubt, ask a mentor.



Junior Activities

Engaging the next generation to become members in the American Legion Auxiliary is the important purpose of the Junior Activities program. Junior membership is open to girls from infancy through age 17. The Junior Activities program prepares girls under the age of 18 to become active adult members of the organization by providing positive volunteer experiences that instill the ideals of the Auxiliary. These young ladies develop leadership skills while having fun and will hopefully become the future leaders of our organization.

Juniors are members of the Auxiliary who are organized as a committee of a unit. Juniors are not a separate organization. Junior members conduct their own meetings and perform their own special activities. Junior members plan their own community service projects, along with supporting projects sponsored by the Auxiliary and The American Legion Family.

The Juniors Patch Program is designed to foster the ideals of volunteer service in our communities and for our veterans. The Patch Program incentivizes active participation and helps Junior members learn about the Auxiliary. An annual Junior Meeting is held to provide these young members with an opportunity to become acquainted with girls from different states and experience multicultural team building while forming exciting new friendships.

Junior members are eligible to apply for the Auxiliary's

National Spirit of Youth Scholarship. Each year, five young women are competitively selected to each receive a four-year scholarship to pursue a college education, currently awarded at \$1,000 per year for four years.



Connecting with our Junior members and involving them in worthwhile activities that support our mission is the best way to ensure the continuation of the Auxiliary for as long as there are veterans to serve.

"For God and Country" we shall serve, faithfully...Amen



Posting or sharing photos of members with adult beverages or advertising the sale of such beverages, is not protecting or establishing a positive IMAGE of our Mission.

We endeavor to correct this oversight by sharing the following inserts from the **AMERICAN LEGION AUXILIARY NATIONAL POLICY: ELECTRONIC COMMUNCATIONS, INTERTNET, AND SOCIAL MEDIA POLICY** which can be found on <u>www.alaforveterans.org</u> under the members only section, public relations program.

Policy Statement: It is the policy of the American Legion Auxiliary (ALA), to have requirements and standards in place for communication conveyed electronically under the auspices of American Legion Auxiliary, including the Internet and social media, that protect the name and trademarks of the American Legion Auxiliary and the reputation of the organization at all levels. In keeping with the vision of the American Legion Auxiliary 2019-20 Strategic Centennial Plan. It is critical, we always remember who we are - the world's largest women's patriotic service organization, and that what we do - serve veterans, the military, and their families, can be enhanced greatly by sharing why we matter through responsible engagement in social media.

Guidelines: The American Legion Auxiliary National organization will publish and maintain current guidelines within the American Legion Auxiliary Branding Guide that include appropriate protocols regarding establishing and conducting American Legion Auxiliary social media and Web presence in keeping with applicable laws, government regulations, and **industry best practices**.

Content: Content considered relevant under this policy includes **proper and suitable postings** about members, ALA meetings, ALA mission-related programming events and fundraising activities, and events or fundraisers that benefit the American Legion Auxiliary.

Monitoring: The ALA will reasonably monitor electronic communications that protect the ALA from threatening or dangerous content, and the electronic media account administrator reserves the authority to remove postings that violate laws, regulations, or **ALA policy**.

Sanctions: Any electronic, Internet-based, website or social media presence using the name, emblem, or trademarks of American Legion Auxiliary that fails to comply with this policy is prohibited. Any cost for enforcement of laws or judgments relative to this policy shall be sought from the offending entity or individual representative.

To be compliant with the Monitoring section of the ALA National policy, we are establishing a list of all ALA Dept. of Florida Units, Districts and Committees using the name, emblem, or trademarks of the American Legion Auxiliary. Please email publicrelations@alafl.org the name of the Facebook page, the administrator's name and email address. The list will be forward to ALA Dept. Administrator/Secretary.

It collaborates with our Veterans Affairs & Rehabilitation, National Security, Education, and Americanism committees, depending on the legislative issue. It mobilizes members and helps to distribute a call to action throughout their spheres of influence.

The American Legion's legislation priorities are as follows:

VETERANS AFFAIRS & REHABILITATION:

- Unify VA programs and limit outsourcing of services, by recruiting and retaining top medical professionals.
- Quality care for women veterans.
- Research complementary and alternative medicine (CAM) treatments for PTSD and TBI.
- Support those who care for wounded veterans.
- Repeal unfair offsets that penalize disabled veterans and widows.
- Support veteran-owned small businesses.
- Continue and make permanent funding programs to end veterans homelessness.
- Streamline the nine community care programs into one effective and simple community care program for veterans.

NATIONAL SECURITY:

- End sequestration and ensure that dwindling budgets don't leave the nation vulnerable to enemy forces.
- Provide mandatory end-of-service exams for

reservists.

• Ensure those returning from active duty retain reemployment rights.

EDUCATION

• Continue to strengthen education benefits for veterans, servicemembers, and their families.

AMERICANISM:

• Protect the United States flag from acts of desecration.

Additionally, in a joint effort with The American Legion, ALA members can advocate at the state level to identify and initiate specific steps that need to be taken to provide transitioning servicemembers and military spouses with the credentials they need as they transition into civilian life, reducing barriers to licensing based on military experience or frequent moves.


How can Units and members accomplish this? Work with local schools to further the education of our Flag and U.S. Constitution. Here are a few examples to help you tell the world....

DID YOU KNOW?

Congress increased TRICARE costs for military retirees and their families who enter the military after January 1, 2018.

Currently, military retirees and their families are exempt from these increased fees. Congress is considering legislation that would remove this exemption, increasing costs for these service members and their families. If passed, this would result in higher TRICARE fees, including pharmacy copayments and enrollment fees for certain plans.

Take Action: Log onto the National Legion or Auxiliary's website. Go to the Legislative page and click on **Take Action** to contact our Senators and Representatives. Demand that they reject any legislation that would result in TRICARE fee increases for current beneficiaries and let them know that veterans have paid for their benefits through blood, sweat, and tears many times over.

I distributed goody bags to the ladies at Sandy Nininger and knew immediately that this idea was a huge hit. Each bag was filled with bracelets, necklaces, pins, scarves, mirrors, combs, just to mention a few of the items. Well, the ladies put ALL of the jewelry on at one time, along with the scarves. It was amazing to see how much fun they were having.

On January 20, the alarm rang at 5:00 so that Gail Dupuis and I could make the drive to Miami VAMC. For those of you that aren't familiar with Miami traffic, it may seem unbelievable that a drive from Ft. Lauderdale to downtown Miami could take 2 hours. Denice Grenis and Gail Dupuis brought their own stylist in to give these female veterans a special cut, rather than the traditional barber cut they are accustomed to. 
