- DO NOT use the same transmittal number on all of the recap sheet.

Several American Legion Auxiliary Florida Juniors are well on their way to receiving the Color Wheel Patch Challenge Certificate. If they earn 2 patches prior to Department Convention set for June 15 – 18, 2023 at Marriot Orlando World Center they can also get a certificate.

All Juniors are encouraged to earn patches regardless of where they live. Even if Juniors live out of state they can still work on projects to earn patches. A new Patch this year, is the National Veterans Creative Arts Festival Patch that Juniors can raise money for National President Vickie's Project. For every year the Junior is in age, they can raise \$5. and receive a patch. So if the ALA Junior is 4 (x \$5) they need to raise \$20. to earn the patch.



## NATIONAL VETERANS CREATIVE ARTS FESTIVAL PATCH

The week-long Festival showcases the creative achievements of veterans receiving treatment at VA medical facilities. Veterans participate in many categories, including visual arts such as painting, sculpting, and drawing, as well as creative writing, dance, drama, and music.

A special Junior patch has been created for our Junior members and SAL youth to be involved in raising money for the National Veterans Creative Arts Festival. Any Junior or SAL youth can earn this patch if they raise at

least \$5 for each year old. For example, a 17-year-old would raise a minimum of \$85 (17 x \$5 = \$85.)

Donations can be raised a variety of ways. Juniors and SAL youth can solicit donations from family, friends, Legion Family members or contribute themselves. Fundraising activities can be coordinated, such as bake sales or other sales, etc. Funds can be raised individually or as a group, but each Junior or SAL youth receiving this patch needs to have raised the required minimum funds for their age. The goal is for the youth of our organization to be involved and aware of the Veterans Creative Arts Festival. Convention in June with their Patches and earned certificates.

The Juniors will have their own canopy tent and table set up. # LEGISLATIVE

SHIRLEY FASHANO



Election Day was Nov. 8, it was a time when American Legion Family members and other voters headed to the polls to uphold their Constitutional right and civic responsibility. And boy did you!!! As citizens and veterans of this great nation, it was our duty to exercise our right to vote and encourage others to do so as

well. And we accomplished this through the Get Out the Vote program established by the American Legion.

Article II, Section 2 of the Constitution of The American Legion, states, "The American Legion shall be absolutely nonpolitical and shall not be used for the dissemination of partisan principles nor the promotion of the Candidacy of any person seeking office or preferment." Legionnaires engaged in partisan activities – such as attending a candidate's rally – should do so without wearing the Legion cap or other Legion attire.

Voting is a powerful way to participate in our government. By voting you are upholding a civic responsibility and demonstrating how we are truly ...Veterans Strengthening America.

The ***Supporting Families of the Fallen Act***, a bill to increase service members' life insurance benefit coverage, was signed into law by President Biden. The legislation increases the U.S. Department of Veterans' Affairs Servicemembers' Group Life Insurance (SGLI) and Veterans' Group Life Insurance (VGLI) coverage amount from \$400,000 to \$500,000. SGLI and VGLI coverage amounts had not previously been updated since 2005. The bill was introduced by Senator Tommy Tuberville.

As you know our leaders are back in session for the Congressional 117th meetings. Still a few items on the

list for the American Veterans. More than 34,000 of our members sent messages to Congress urging them to pass the PACT Act before their break. Thank you! Your letters and phone calls are working.

Be aware of all the bills on the table through the American Legion website. We support Bills for our American Veterans, their spouses, and family. Here's one of many...

## **H.R. 4673- Ensuring Veterans' smooth Transition (EVEST) Act**

**Automatically Enroll Veterans for Benefits** The bill requires the Veterans Affairs Department to automatically enroll in the department's system for VA health care benefits and services those individuals who are separating from the military and transitioning to civilian life, and to also create an electronic mechanism through which those veterans can disenroll if they desire.

**Some** say it will help ensure that veterans don't go without needed health care during their transition from military to civilian life. **Some** oppose the measure, saying that while they support the bill's underlying intent there are too many unknowns and that it was not developed on a bipartisan basis.

On 01/20/2022-11:38am- House Passed by the Yeas 265 and Nays 163 (Roll no. 14).

On 01/20/2022 Senate Received in the Senate and Read twice and referred to the Committee on Veterans' Affairs.

Keep track of everything you do come November during the elections, pole watching, street walking, campaigning, etc. There will be an award given and a surprise bonus.

Throughout my emails you will note I give both "sides", because after all there are two sides to a story. I will also send information which may not be a Bill, however, is important to our American Veterans and for the

American Citizens.

It seems we are at war with fossil fuels, and has been for several years. This is causing gas prices to skyrocket and puts America at risk. Some think prices are decreasing, while others say these prices are still burdensome. America is now using up our Strategic Petroleum Reserve (SPR), while some think using our SPR hurts America.

America in the last couple of years has sold off **nearly 40% of our reserves**. This past month, the administration announced that they will soon use an additional 15 million barrels, and they have no plan to refill our SPR. This seems to be a concern to some saying it weakens our energy security and national security.

Is America currently unprepared for a true emergency forcing us to go to countries like Saudi Arabia and Venezuela. Or are we energy independent? Do your homework and make a decision for yourself. Then work any way you can to let our leaders know you love or dislike it. This is a way for us to help each other with the rising cost of gas. Inflation is hurting us all. We need to figure out a way to work together and make a reasonable plan for the average American.

In the year since the withdrawal of U.S. military forces from Afghanistan, the United States has welcomed more than 76,000 Afghan evacuees into the country. They include human rights and political activists, women who served in the government and armed forces, those who

served alongside American troops and others deemed to be at immediate risk.

The evacuation was the largest effort since the Vietnam War. While many evacuees reached safety inside the United States, tens of thousands of U.S. allies remained. Their service alongside American forces made them — along with their families — targets for retribution as the government crumbled and the country fell back under Taliban control.

Days before the first anniversary of the U.S. withdrawal from Afghanistan, legislation was introduced in both chambers of Congress that could provide those 76,000 Afghan evacuees in the U.S. with a pathway to permanent residency. Many are eligible for asylum or special immigrant visas (SIV) due to the critical assistance they provided to the U.S. during 20 years of war in Afghanistan.

### **The American Legion-supported Afghan Adjustment Act of 2022 would:**

- Establish a pathway to permanent legal status for Afghans brought to the United States on a temporary humanitarian status by allowing additional vetting to apply for permanent legal residency. This includes those who supported the U.S. mission in Afghanistan over the past two decades.
- Expand the SIV program to include four previously omitted groups, including the Female Tactical Teams of Afghanistan, the Afghan National Army Special Operations Command, the Afghan Air Force and the Special Mission Wing of Afghanistan.
- Establish a task force to develop and implement a strategy for supporting Afghans outside of the United States who are eligible for SIV status and require the Department of State to respond to congressional inquiries about SIV applications.

"Giving our Afghan allies a chance to apply for permanent legal status is the right and necessary thing to do," said Sen. Amy Klobuchar, D-Minn. "This bipartisan legislation will help provide these newly arrived Afghans who have sacrificed so much for our country with the legal certainty they deserve as they begin their lives in the U.S. It's important to do what we can to help our Afghan friends find stability, opportunity and community in their new home." # DISTRICT 15 EDUCATION

Greetings friends and neighbors!

I am Sheryl Kinsler and I have the honor of serving as the education chairman for 15th districts, Town and Country Memorial unit 152, Tampa, FL and I would love to share with you what our unit (with the help of some others) has been doing so far this year.

Our unit hosts an annual collection of school supplies for schools in our area and each year is a little different. Unit 152 has 4 title one schools in the immediate area. Last year the request was hand sanitizer and child size masks, this year however the requests were personal water bottles as the water fountains in the schools are still not being used due to Covid and headphones along with the normal items such as tissues, pens, pencils notebooks etc. I am proud to say that Unit 152 has thus far donated over \$1,000.00 in school supplies to these 4 schools but we did not do it alone. Unit 238 donated 25 pairs of headphones, countless spiral notebooks, pencils, pens, folders highlighters.

I felt a sense of pride and many times had to fight back the tears while delivering these much-needed supplies when the schools expressed the sense of gratitude while explaining how many students our donation will help.

The supply drive was so successful this year that we have

decided as a unit to continue it year-round as the need is not only there at the beginning of the school year. Each month will have a theme, October is facial tissue, November is Hand Sanitizer and December is filler paper and crayons, lots and lots of crayons.

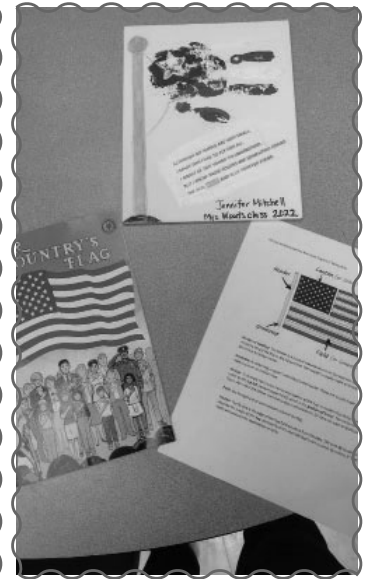
Hillsborough County has over 4000 homeless students enrolled this year. Homelessness does not necessarily mean living in a car, it can mean a variety of things but primarily an individual or family who lacks a fixed, regular, and adequate nighttime residence, such as those living in emergency shelters, transitional housing, or places not meant for habitation. Further, I personally did not understand what a title one school was so I googled it and this is the description of a title one school. Schools in which children from low-income families make up at least 40 percent of enrollment are eligible to use Title I funds to operate schoolwide programs that serve all children in the school in order to raise the achievement of the lowest-achieving students.

I feel that I would be remiss if I didn't offer a few kinds words and a great big shout out to the American Legions families that have and are coming to the aid of our friends and neighbors in southern Central Florida as they continue to need our help in recovery from the devastation of Hurricane Ian. Our thoughts and prayers are with you all!

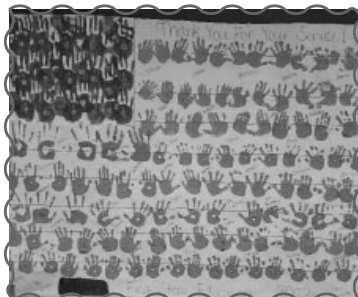

## UNIT 318

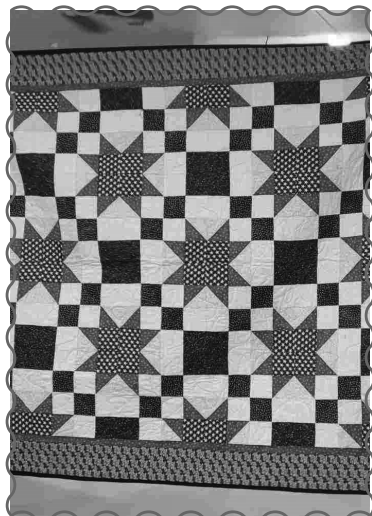
