PRESIDENT'S MESSAGE

ANN KING-SMITH

The month of August has always seemed like an "in between" month to me. Summer isn't quite over (especially here in Florida) but Fall has not arrived either. With the ongoing pandemic looming, I'm sure we probably feel that "in between" feeling more than ever. Here in Florida, we usually monitor just what to do and when to begin by events such as Bootcamp, Workshop, National Convention, and District School of Instruction. With most of those events cancelled, it leaves many of us wondering just where and how to begin.

Over one year ago, I chose my Department President's theme "Florida ALA Strong" and today, I am prouder than ever with that choice. During the past months, I have read stories and seen pictures of ways that American Legion Auxiliary members are proving that we are ALA Strong. Working together, we have discovered ways to "think out of the box" and make things happen. Units have held elections, meetings and installations successfully. I was extremely impressed with some of the great ideas you had for making things work for your members. Your Department Executive Committee held our very first Zoom meeting to approve our 2020-2021 budget. Although it lasted about 6-1/2 hours, we were able to get the job done, with the help and guidance of Finance Committee Chairman, Kelli Becraft Coppla.

As most of you know, Honor Flight will remain the President's fundraising project for the 2020-2021 year. Some of you are under the impression that Honor Flight has cancelled all trips for the year. I am happy to report that this not their plan. All 10 Hubs have postponed flights until Spring 2021, in the best interest of our veterans. Now, more than ever, we need to focus on raising money to help them send even more veterans to Washington, D.C., since they now have a backlog. Although COVID-19 caused many of our fundraising efforts

to be cancelled, we were able to distribute

\$54,446.40 to our Florida Honor Flight Hubs. Each Hub received a check in the amount of \$5,446.64 to assist them in their mission. Although this amount was less than the original goal, we must remember that we "lost" months of fundraising, not to mention our great Parade of Checks that takes place at Department Convention. Each Hub was incredibly grateful for the generous donation they received. As a special treat, Honor Flight Hubs will be submitting articles to each edition of Mail Call. I think these articles will give us all a better insight about how our veterans are served. This first article is in this edition, so please take time to read every word.

It pleases me to report that all Department Chairmen from the 2019-2020 year have agreed to serve in that capacity for another year. Each of these leaders are extremely committed to bring information about our ALA programs to each member. This will be more of a challenge this year, in the absence of our Department Bootcamp and Workshop. Program Action Plan changes are minimal, and all changes made by our National organization have been written into all plans. We are currently in the process of posting these updated plans on our Department website, www. alafl.org. Please make sure and check for any updates to our programs.

As I told you last month, all our District President's agreed to serve again except for one. Faye Kirkland agreed to fill that position, for which I was extremely grateful. Unfortunately, District 11 President Dee Butler submitted her resignation recently, due to family health issues. I know we are all grateful to her for her service and will be

During the pandemic, Department Secretary Patty MacDonald and I have been attending weekly

online meetings with our Department Commander and leaders from Sons of the American Legion and Riders. During our meeting this week, a request was made by Commander Rick Johnson regarding our use of Facebook. Although your personal Facebook page is your forum for sharing personal comments, information and thoughts, Commander Johnson asked that we DO NOT use Facebook to discuss any recent issues (Post closings, etc.) hat involve the American Legion Family. He certainly requests that members continue to send direct correspondence to our elected officials and representatives concerning these issues. 


Oh no! What's going on now?

CONSTITUTION & BYLAWS

CATHERINE MCMULLIN

The world as we knew it has changed. Not one of us expected what we are now going through would ever happen again despite what history had taught us about the Spanish Flu. Wearing masks, social distancing (no more hugs, sniff, sniff, I love hugs) and staying home working and/or catching up on some old movies we have not seen since we were children.

But at the same time it has given us an opportunity to think about "Now what does this mean going forward?" Does our state of FL allow for electronic meetings? What does our Dept. of FL need to do to allow for alternative ways to conduct business? Do our governing documents prohibit electronic meetings?

Taking those questions one at a time "Now what does this mean going forward?" It means we must be flexible and embrace the changes. The emergency situation does not allow for us to "do it the same way we have always done it".

Does our state of FL allow for electronic meetings? The Florida Statute pertaining to Emergency bylaws states: "(1) unless the articles of incorporation provide otherwise, the board of directors of a corporation may adopt bylaws to be effective only in an emergency defined in subsection (5). (5) An emergency exists for purposes of this section

if a quorum of the corporation's directors cannot readily be assembled because of some catastrophic event.

What does our Dept. of FL need to do to allow for alternative ways to conduct business? A review of the Dept. of FL governing documents found that they do not prohibit electronic meetings. What does our Unit need to do to allow for the new way things are being done? Until the Dept. of FL has updated their Constitution and Bylaws, you may insert into your Standing Rules the following suggested verbiage:

"Unit meetings may be held in person or via electronic means.

Voting may be by voice, ballot, email or other electronic means."

Going forward we will need to be attentive to keep up with any and all changes. Be sure to review your governing documents at least a couple times a year. Most of all, be prepared. We can no longer fall back on "If it ain't broke, don't fix it". Let's be proactive, not reactive.





Happy Summer folks.....I hope you are all enjoying the summer breezes, staying safe, social distancing and preparing for a new year of American Legion Auxiliary Education happenings.

Many things have occurred in the last year that could actually sideline many and prevent success in efforts to contribute to our communities. BUT NOT US.....Not the American Legion Auxiliary! We are the BEST and we will forge ahead as planned and complete as many efforts as possible in schools and communities in the state of Florida to enhance education.

First be aware that Article IX, Section 1 of the Florida Constitution relates to public education and provides that "the education of children is a fundamental value of the people of the State of Florida. It is, therefore, a paramount duty of the state to make adequate provisions for the education of all children residing within its borders. Adequate provision shall be made by law for a uniform, efficient, safe, secure, and high quality system of free public schools that allows students to obtain a high quality education..."

Now.....these are very unusual times and I fear that we will need to really think outside the box and prepare for providing supplies and information in a very different manner than what we have experienced in our very storied past of success in providing for and enhancing education in our communities.

Because there are no rules set out as yet for a safe return to school by the State of Florida, we can assume at this point that they will not allow us entry to a school. Therefore creativity must be used in our overall efforts.

Consider in Give 10 For Education....make sure that schools know when you were packing items,

you wore gloves and a mask. Also, you may want to also let those

supplies sit in a closet or some other place with no human activity around it for 24 to 72 hours prior to delivery. Assure them that you have indeed taken precautions in packing.

It may be possible for you to conduct a Virtual meeting with a veteran via ZOOM. The need and challenge would be to find a teacher willing to participate. ZOOM is easy and free for a 30 minute session using a smart phone, tablet or computer with a camera. I would suggest a phone call or letter to a school principal extending the invite.

Once again our Posts are closed...unless one has a restaurant license. Our veterans will suffer the loss of socialization. It may be an opportunity to visit with a veteran and conduct a interview, on subjects that would be presented in a classroom by a veteran. Compile the information in a letter for presentation by a teacher. Consider asking a local newspaper to assist and it might be an opportunity for publication.

So, as you see, we still have opportunity. Our roadmaps are not as clear as in past years BUT we have an opportunity to create new pathways and attain success in what we do.

The Box Top program is digital....
Can you assist with Virtual tutoring....we have websites....

School systems may still allow for people to assist on bus patrols....

Fall Conference has been scheduled...it's on the calendar. I hope to see many of you there. Perhaps by then we will have more information on how we can again promote all we love and do for education in Florida.

GET TO KNOW YOUR MILITARY

What is the military? In simple terms, the U.S. Armed Forces are made up of the six military branches: Air Force, Army, Coast Guard, Marine Corps, Navy and, most recently, Space Force.

- There are two general categories of military people: active duty (full-time soldiers and sailors),
- reserve & guard forces (usually work a civilian job, but can be called to full-time military duty,

And of course, there are the millions of family members and friends of military members, past and present.

There is much to learn about the Military... So first, here are some of the basics.

Who Is in Charge of the 6 Military Branches?

The President of the United States is the Commander in Chief, who is responsible for all final decisions. The Secretary of the Department of Defense (DoD) has control over the military and each branch --except the Coast Guard, which is under the Dept. of Homeland Security. With over 2 million civilian and military employees, the DoD is the world's largest "company."

What are the Branches of the Military?

Each branch of the military has a unique mission within the overall mission of U.S. security and peace. In addition to the six branches of the military, the Army and Air National Guards also serve their own special functions. Here is a rundown:

Air Force and Air Force Reserve:

The nation's source of air and space power. The primary mission of the USAF is to fly planes, helicopters, and satellites.

Air National Guard:

The Air National Guard as we know it today is

a separate reserve component of the **United States Air** Force.

Army and Army Reserve:

The dominant land power. The Army generally moves into an area, secures it, and instills order and values before it leaves. It also guards U.S. installations and properties throughout the world.

Army National Guard:

The Army National Guard is an elite group of warriors who dedicate a portion of their time to serving their nation. Each state has its own Guard, as required by the Constitution; in fact, it is the only branch of the military whose existence is required by the Constitution.

Coast Guard and Coast Guard Reserve:

The Coast Guard's mission is primarily with domestic waterways. The Coast Guard does rescues, law enforcement, drug prevention, and clears waterways.

Marine Corps and Marine Corps Reserve:

The Marine Corps is known as the U.S.' rapidreaction force. They are trained to fight by sea and land, and usually are the first "boots on the ground." Marines are known as the world's fiercest warriors.

Navy and Navy Reserve:

The Navy accomplishes its missions primarily by sea, but also by air and land. It secures and protects the oceans around the world to create peace and stability, making the seas safe for travel and trade.

Space Force:

The newest branch of the military, the U.S. Space Force was signed into law in December 2019. The Space Force currently does not have a reserve component. The sixth branch of the military, the Space Force is also still in development and will be for some time as many final decisions are made, including uniforms,

When would you call in someone for help with your unit? Most conflicts are personality clashes. We all have different personalities and can usually be worked out by speaking with the person of conflict and just letting them know how your feelings were hurt. Speak to each other and see if things get better. Sometimes your conversation does not help. then you may need someone from the outside to come in. What you need to do is get familiar with Roberts Rules and if motions are being made during General Membership Meetings, you as a member have the right to vote on all actions being put before the membership. Other sources of information and procedures are the National Auxiliary Unit Guide, the Florida Unit Guide and our Florida Chairman's Guides that are on our web site at alafl.org. Sometimes you may feel that your treasurers report is incomplete. If you have guestions, please ask, so they know you care about what is going on with your unit funds. When you have a question please ask it in a manner that you are only seeking knowledge of what your unit is doing.

With this Pandemic everyone has questions about how to hold unit elections. You as a member should have had a right to vote. If you wanted to be an officer, you should have had the opportunity to nominate yourself if you wanted to run.

Department emailed out the proper procedures of unit voting during this pandemic. This year we have had a lot of firsts. Your units have been challenged a lot this year. All units from time to time may make a few mistakes. We as members need to learn and grow. We need to remember that our primary focus is assisting our veterans and their families in our local communities.

If there is a problem in your unit and you think things need to be addressed go to the alafl.org web site under quicklinks and go to forms and resources. You will find UD&R Assistance

Request under unit forms. Submit the request to department. After you have submitted the form request, Robin Burke or myself will contact your unit to setup a meeting with your unit members and hopefully be able to help suggest things to help your unit function coherently. We fail to help our veterans if we cannot get along. The

desires of your unit are for your members working together for the good of your unit, your organization and your community.

We as a unit member may not realize that we must be a member of the parent organization of the Post to assist with the Bingo Program. Florida Statutes are noticeably clear that to volunteer for Bingo you must be a member of that Post, Auxiliary, or Sons of the American Legion. By Florida law these are the only volunteers that may help with your Post Bingo Program.

In todays world all units go threw a lot of change and we all need to expect change. Just because someone is doing it different than the way it was done in the past does not mean they are doing it wrong. The changes may be good and if you offer to help you may suggest some items for discussion. If you were the chairman, you could do it a little different if your program gets completed as intended for our organization. Changing from having a dinner to let us say cookies and punch may be necessary for not enough members are available to put on a dinner that day. Please remember to have this discussion with your members during a General Membership Meeting. We as an organization function as the Executive Committee makes recommendations to the General Membership Meeting and the General Membership Meeting makes the decisions for our unit. We are a membership driven organization and our members determine what and how the unit intends to accomplish its goals and what programs the unit shall accomplish.

I ask you to take away from this article your rededication to assist your American Legion Auxiliary Unit in every way that you can. Also, to conduct the programs of the Auxiliary and assist the American Legion with their programs to assist the veterans and veteran families of our communities.

Back in the spring of 2018, Honor Flight Central Florida received an application from a WWII Veteran named Louis K Plummer, "Uncle Lou" as he is known, got a priority call from our Director of Veterans, Nancy, who came to find that Uncle Lou had served with the Tuskegee Airman during his time in the Army, and before his subsequent service in the Air Force following the war. Uncle Lou represented that he had some health challenges to be sure, one, a prior double knee replacement, that pretty much restricted him to a wheelchair (lightly armored personnel carriers in Honor Flight nomenclature). He had never viewed the glorious Veteran memorials in the capital, or visited Arlington Cemetery, and being on an Honor Flight was a "bucket list" item for him. He also had a full-time caregiver and nurse that insisted she join him, if the trip was at all possible for him to make. Nancy assured Uncle Lou that if his doctor authorized him to travel, we were more then up for the challenge to care for him, and that his nurse "Robbie" was welcomed to act as his Honor Flight Guardian. At the time, Uncle Lou was 98 years young.

Given our normal priorities and working in the context of his schedule, we arranged for Uncle Lou to join us on one final mission, one of honor, along with 49 other Veterans of WWII, Korea and Vietnam.

When we met Lou, along with our other Honorees, at our pre-flight mission orientation, he was a little overwhelmed with the attention he got. He didn't know there was a "buzz" among our Board, Staff and Volunteers that we had an opportunity to honor someone who was a part of the Tuskegee Airmen group, and he was greeted with welcome arms and lots of hugs and kisses, as all our heroes are.

So, in September of 2018, we had the honor of taking Uncle Lou, and 49 more of our heroes up to DC on their Honor Flight. Unbeknownst to Uncle Lou, family members of his whom we had contacted, were as excited about his Honor Flight as much as he was. They asked for our day's agenda, because they had plans for several members of his extended family to surprise him with a visit when we stopped for lunch at the Air Force Memorial, and join him after lunch at the National Mall when we arrived at the WWII Memorial. We were pleased to take a part in that surprise, and his family spent about three hours with their beloved Father and Grandfather that day, and it only added to a day Lou had looked forward to for some time. They came from all around the east coast, all focused on their own mission. It was a day to remember for Uncle Lou.

We love the personal connection that we can enjoy with our heroes, and Lou was no different. We are blessed to hear stories first-hand of their service and sacrifices. The memories they share are treasured by our team, and I made a connection with Uncle Lou that meant so very much to both of us. While Lou was attached to the Tuskegee Airmen, he himself was not a flyer. He serviced the aircraft as a trusted mechanic. Lou told me that at one point, the unit served under General Joseph Stillwell in the China-Burma-India theatre, and recounted how the General's sour disposition earned him the nickname, "Vinegar Joe". During his time in the Army, Lou helped maintain aircraft on the Broadway landing field in Central Burma. Lou was surprised that I was familiar with Stillwell, and the service of those who were there in CBI. I explained that I knew all about that mostly forgotten theatre of battle in WWII, because my own father was one of the men who built Ledo



Road, and the Broadway landing field in Burma, and I shared some treasured pictures of that place, and my Dad. As a tribute to my Dad, I wear a CBI insignia on my Honor Flight lanyard, and as a tribute to Lou, I presented one to him. He fought back tears when I presented it. Lou shared his memories, and I shared some of my Father's service with him. It's a connection I'll never forget, with a man I would never know, except for Honor Flight.

Last week, my phone rang, and the caller explained that she was calling on behalf of Lou

Plummer. He wanted to wish me a happy Father's day, and let me know his Honor Flight was one of the happiest days of his life. Uncle Lou is 100 now, and that gives him a lot of days to compare it with. He may never know that he gave me one of the happier recent days of my life with his call. I teared up speaking with him, but since tough guys don't like to admit things like that, I'll just call what Uncle Lou and I shared "Honor Flight allergies". A side-effect of those allergies is memories you'll cherish forever, like Uncle Lou and I do.
