Congratulations on your appointment by the Unit President as Parliamentarian for the Unit. As parliamentarian you will be the expert on parliamentary procedure and should have the following tools:

1. Copy of Unit Constitution, By-laws and Standing Rules
2. National Unit Handbook
3. Current Department Unit Guide
4. Robert's Rules of Order, Newly Revised
5. Robert's Rules of Order Newly Revised "IN BRIEF"

Before each meeting you should review the agenda with the Unit President to be familiar with the business and possible procedural problems that may arise. You will also review and know the bylaws and standing rules of the Unit. You also work with committee members who request assistance in preparing reports for the meeting.

Over the next few months, I will cover certain things that you should know, and today's lesson is presenting a motion. A proposal for action is made in the form of a motion. For the members to consider a motion, at least two members must be in favor of it. The first member stands and

makes the motion. The second member seconds the motion to show agreement that the motion should come before the assembly. Seconding a motion does not signify that the member is in favor of the motion; she simply wishes the subject to be discussed.

There are eight simple steps in presenting motion:

1. The member rises and addresses the chair.
2. The member is recognized by the chair.
3. The member states her proposalI move that (state the proposal)
4. Another member seconds the motion.
5. The motion is restated by the chair.
6. The chair then asks for discussion.
7. After discussion the chair puts the question to a vote: all in favor state yay, all opposed state nay.
8. The chair announces the result. The motion either passes or fails.

HONOR FLIGHT

STORY OF MARTIN GOUYD

Most Americans are unaware that the US Merchant Marine, those civilian crewmen and officers who sail commercial non-naval ships carrying cargo or passengers or provide maritime services, were the unsung heroes of World War II.

These daring seamen kept the Allied troops armed and fed while, essentially defenseless, were at the mercy of German U-boats.

During World War II the ships and men of the United States Merchant Marine transported across the oceans of the world the vast quantities of war materiel, supplies, equipment and troops needed to fight and win that war. The men of the US Merchant Marine were civilian volunteers who nonetheless died proportionally in numbers that rivaled or exceeded any branch of the uniformed military. Like the US Navy Armed Guard with whom they sailed, the unrecognized men of the US Merchant Marine made possible the Allied victory in World War II.

It is rare that Southeast Florida Honor Flight receives a veteran application from a WWII Merchant Marine. Martin Gouyd is that rare veteran. Mr. Gouyd, 94 years old and legally blind, has been rescheduled for his Honor Flight twice this year due to all trips being cancelled because of the Covid-19 virus. He is scheduled to fly on his Honor Flight on April 10, 2021 and is exceedingly excited about it. We caught up with this jolly, effervescent gentleman to hear what he did, and how he survived, his service in WWII.

In January of 1944, Jay Gouyd signed up at the age of 17 for the Merchant Marines out of a recruiting office in Buffalo, NY. After six months of basic training, he elected to go to radio school—all radio

operators on MM ships had to be FCC-qualified. Six months later he was on board his first ship, laden with wartime cargo to supply the troops—trucks, tanks, munitions. Luckily, they

were escorted through the churning winter seas of the North Atlantic by Canadian destroyer escorts. They unloaded their cargo in Cherbourg, France and being empty, cruised to Ghent, Belgium to load up on stones for ballast to make the journey back to the US. All the while, Mr. Gouyd experienced the nightly barrage of V2 rockets overhead as Germany actively fired at England.

After a week back in the US, their ship was loaded to the gills with 500-lb. aerial bombs to head back to the European Theater. Two days into the voyage, they were redirected to the Pacific Theater with the notification of Victory in Europe. They headed to Panama, through the canal, on to Eniwetok Atoll and Saipan, a forward bomber base. Then on to the Battle of Okinawa where Martin witnessed Japanese kamikaze pilots bombing ships all around him. By that time, their ship was outfitted with four anti-aircraft guns and he manned one of them. He said, if they had known what cargo they had on board, it would have been one helluva explosion!

Soon VJ Day came, thankfully, and their ship headed to the Philippines where all of the bombs were unloaded and sunk in the ocean. Their ship was outfitted for troop transport and was given to Japan to retrieve their POW's. Mr. Gouyd headed home. As he said, he was one of the lucky ones. He wanted to serve his country and met many wonderful people along the course of his service.

Most of the mariners who sailed against the U-boats are gone now. The few thousand who remain have often felt the American gratitude has never fully included them. But it's still not too late to remember, belatedly, how much we owe them. And Southeast Florida Honor Flight looks forward to the honor of celebrating the service of Martin Gouyd in April 2021!



SECRETARY/TREASURER

Greetings from Department Headquarters! We hope this finds you all well and in good health. Brandi and I have had numerous questions in reference to membership credit report and obligations, so we are going to address them in this article.

Obligations (aka Quotas)

Obligations are billed yearly to each unit around July per page 64 of the Department Unit Guide. They are for Rehabilitation, Education, Undergarments and Girls State. Rehabilitation is calculated at \$1.55 per senior member paid at close of books. Education is calculated at \$0.55 per senior member paid at close of books. Girls State is calculated at \$0.60 per senior member paid at close of books. Undergarment is calculated based on the unit membership grouping. The invoice also includes the yearly bonding fee (collected by Department and paid to National) of \$6.00.

The money collected goes toward the veterans in our VA hospitals, Education scholarships and the cost of Girls State. The money is earmarked for these programs and can not be used for anything else.

Obligation invoices are due upon receipt. Units will not be able to purchase a slot for Girls State without paying the obligations prior to receiving a Girls State slot.

Membership Credit Report (MCR)

Membership credit report is provided to the membership chairman via email each month. The MCR will provide the unit with a credit for any member who paid their dues with National. It will also include any credits or shortages from transmittals processed by Department.

The membership chairman is responsible for reviewing the MCR each month and reviewing any credits or debits. If the ending balance is a negative number in parenthesis it is a credit to be used on

future

transmittals. A positive balance (no parenthesis) is the amount owed to Department. A separate check will need to be submitted with MCR in the memo section. Please note you have 60 days to submit any corrections on the MCR to Department.

How to read the MCR

When a member pays their dues to National their membership card is mailed to them by National Headquarters. Department receives notification from National of all the members who paid in that time frame. Brandi Seeber (Department Treasurer) then adds the date to the MCR and the credit for the unit's portion of the dues. An email is sent when she receives the notification from National of who renewed online.

When a transmittal is submitted with credit being used it will show as a shortage for that transmittal on the MCR.

If a transmittal is submitted and a member could not be processed a memo will be sent to the unit explaining why and a credit will be shown on the MCR.

It is the unit membership chairman's responsibility to keep track of credits used in between MCR's being sent.

Units should have received an MCR summary titled "Important Information Regarding the MCR" with the 6.30.2020 MCR. If you did not receive or need an additional copy, please email Brandi at Treasurer@alafl.org.

When we began working on our Girls State Program for the 2019-2020, we did not know what the future had in store for us. You adapted and were willing to do what it took to keep the program rolling. Districts and Units were all for holding phone conference orientations and changing dates if needed, but did not imagine at the time that Girls State would have had to be canceled. As we move forward to preparing for the 2020-2021 Girls State Session, we will hold true to the Girls State Motto: "Forward Forever, Backward Never, within ourselves our future lies."

Our 2020-2021 Girls State Session dates are June 9th-17th. The Program Action Plans, the Girls State Chairman Guide, Mid-Year, and End of the Year Reports are now online. Mid-Year Report should be easy this year, if you sent in a Mid-Year to your District Chairman or me, unless you have done something after reports were sent in, you will just need to indicate that on the report and return to your chairman. Mid-Year Reports are due to District Chairman December 1st, District Chairman are due me December 15th.

Schools are now in session, but are looking differently this year, with student being given a number of options on how they will attend school. You can begin contacting schools and giving them information about Girls State. As things progress you can determine how interviews will be held.

ALA Girls State Over-Quota Unit Registration All quotas (rehabilitation, education, Girls State, and sock) must be paid to Department of Florida by January 31st, 2021. The over-quota registration fee is \$400.00. Please note: Unit Obligations must be paid, and unit must be at charter strength (10 paid seniormembers) to register for ALA Girls State. Only units who have reached the 100% goal in membership by January 31, 2021 are entitled to apply for Over-Quota delegates. Quota amounts

and fees cannot be included with regular registration fees. If your unit chose to have Department hold your Girls State Delegate Money and you have paid your unit Obligations you need not reapply unless you want to send additional girls.

I will keep your District Chairman updated on changes and additional information as the year progresses. If you have any questions, please feel free to call or email me.

In closing, I have included below an email I received this week from one of our Girl State Delegates. (Used with permission).

My name is Victoria Adams. I was one of the few lucky girls that was able to attend Girls State during the Summer of 2015. Nearly five years later, I am still in shock that I was chosen to be able attend Girls State. Considering that Girls State is as exclusive as it is, I was not initially chosen to attend. However, a friend of mine had stepped down from attending Girls State that summer because she had another opportunity out of state. This had given me the opportunity to attend. To this day, I even keep in touch with girls from Manatee City, and my two maroon Girls State polos hang in my closet still.

During the three days at the Florida Capitol, I was a member of the House of Representatives where I worked to pass bills including EpiPen Education and many others. At the end of Girls State, I was awarded Florida Girls State Outstanding Citizen for the City of Manatee in the State of Seminole. I proudly hang my plaque of recognition in my room to this day.

Without a doubt, Girls State changed my life forever. Before Girls State, I had wanted to study medicine in

American Legion Auxiliary Hospital Representatives needed for the State of Florida!

Do you love helping veterans? Do you have time to volunteer? Are you interested but do not know much about what is required? Here are some facts regarding becoming a hospital representative.

1. How much time do I need to devote to the hospital?

The Compensation plan is based on a system of "classes" of hospital representatives, which allow more flexibility for our volunteer's busy schedules.

- A. Hospital Rep I requires a minimum time commitment of 72 hours per month, starting at \$300.00 per month.
- B. Hospital Rep II requires a minimum time commitment of 48 hours per month, starting at \$200.00 per month.
- C. Hospital Rep III requires a minimum time commitment of 24 hours per month, starting at \$100.00 per month.

2. What if there is a day that I cannot come to the hospital?

You can set your own schedule....plus...
Representatives shall receive the following PTO
after six (6) months continuous service:

- A. Hospital Rep I:
1 year service - 18 hours
2 years' service - 36 hours
3+ years' service - 54 hours
- B. Hospital Rep II:
1 year service - 12 hours

2 years' service - 24
hours
3+ years' service - 36
hours

- C. Hospital Rep III:
1 year service - 6 hours
2 years' service - 12 hours
3+ years' service - 18 hours
3. What are some of the other duties that I could be performing?

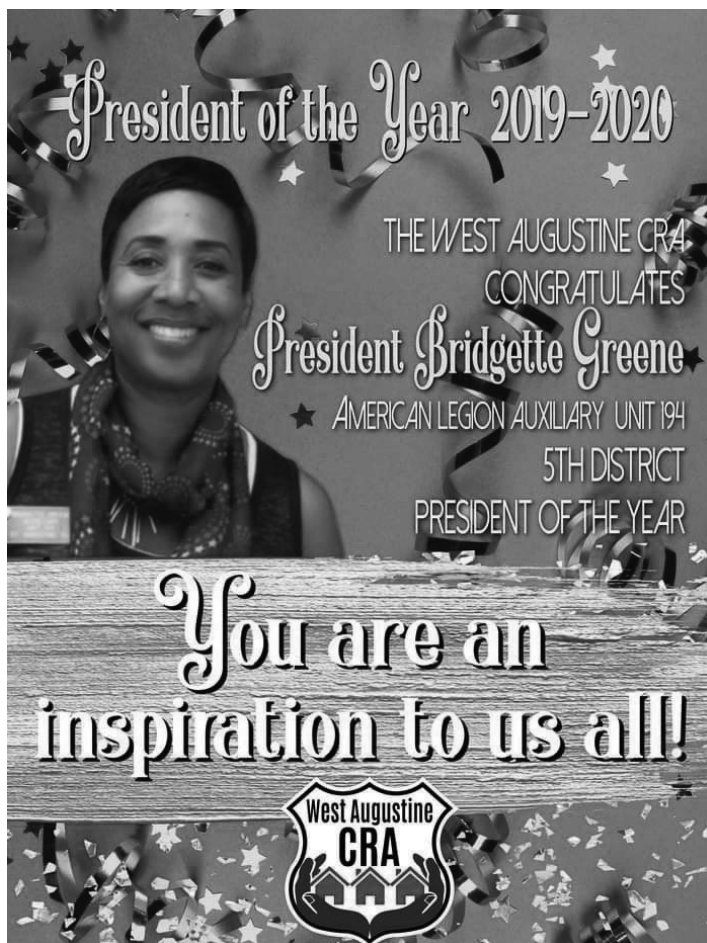
Each Hospital is a little different so the duties may vary from location to location.

- You may be asked to straighten, organize, and distribute personal hygiene and clothing from a closet or storage room.
- Accepting donations for veterans, you might help the public fill out donation form.
- Handing out snacks, beverages etc. to veterans.
- Working with the VA Head of Volunteer Services: volunteering for Events, filling in for another volunteer, or generally anything they may need.
- Work with The American Legion Auxiliary to inform them of anything that is needed for the Hospital.

Differences don't have to divide people, especially when individuals unite under a shared selfless mission of helping others. Just ask American Legion Auxiliary member Denise Holmes, and her fellow Auxiliary members, of ALA Unit 199 in West Palm Beach, Fla. Holmes is the only white person who belongs to Unit 199. Her fellow ALA members there are black.

"I never worry about being racially different from everyone else in our unit. Each of us is there for the same reasons. We all want to honor and help our veterans and their families, and do positive things in our community. Unit 199 is a group of good people. I never have pressure to do something to impress everybody or try to fit in; I already fit in. And I have always felt welcomed in our group," said Holmes, who has been a member of Unit 199 since 2004.

Unit 199 President Elizabeth P. Robinson said she appreciates Holmes for her many positive attributes as a person, and as an ALA member.

"Denise is an awesome person. She is among the first in our unit to say, 'Here's what I can do to help.' Denise is here to serve, to follow the same mission and vision as the rest of us. We're united because we want to make the lives of veterans and military families better, and we want to work with our Legionnaires," Robinson added.

Holmes learned about the ALA from several ladies at the AME (African Methodist Episcopal) church she has been attending for years. They invited her to a meeting at Unit 199 so she could learn more about the American Legion Auxiliary. She liked what she saw and heard, and she became a member.

"When I joined, I felt that things just flowed. It still does. I love it. It's touching to see people doing something to honor veterans. They sacrificed a lot. And it's not just the person in the military. It's their spouse, their children, their parents, their siblings. Helping and honoring all of them is a worthy cause. I wanted to be part of that," she said.

"Unless they dissolve Unit 199, I don't see myself at another unit. I like this unit. I'm comfortable here. And when you go where you're comfortable, you get things done together," she added.

Holmes joined the ALA under the military service of her father, U.S. Army veteran George M. Thompson, who served during the mid-1940s. She has other relatives who served in our nation's military, including an uncle; a grandfather; and her husband, U.S. Air Force veteran Eddie H. Holmes, Jr., who served in the Korean War. Three of her husband's sons also served in the military.

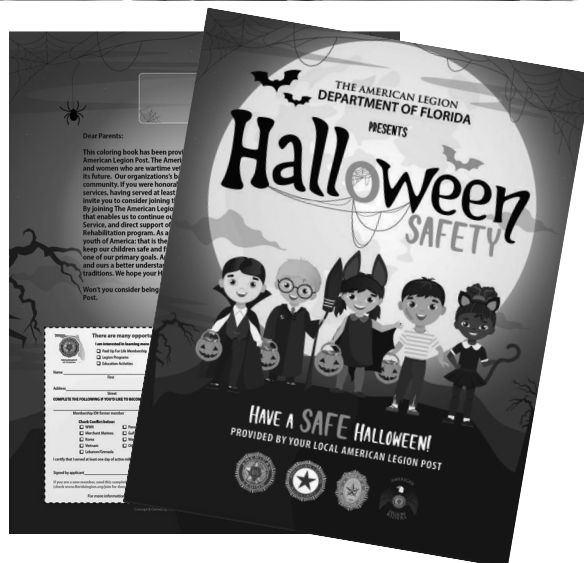
