Greetings from Mulberry! My name is Jasmine Harris, and I am a Junior Member of Mulberry Memorial Unit 72. I am eligible for membership through my Dad, Jeromy Harris, who is an Army Veteran. I am currently the Honorary Department of Florida Junior President as well as the Honorary National Southern Division Junior Vice President. I am a Sophomore in High School, attending Summerlin Military Academy. I enjoy playing softball, both for my school, and for the Lakeland Lady Legends, a travel ball team. When not at school or playing softball, I enjoy volunteering with projects in my Unit. However, volunteering has been more difficult since the pandemic has started. I try to do what I can at home to help, including clipping coupons for our Military families.

Speaking of COVID, as if high school wasn't stressful enough, now we have all of these restrictions to keep us safe! We wear masks from the time we board the bus, to the time we get off the bus in the afternoon, with a break from them while we eat lunch (that's about the only time we can truly tell who is who under the masks!). Our walkways and hallways are all one way. We eat lunch in our classrooms. Our desks are spaced out and there aren't as many students physically at school right now. We have our temperature taken each morning. And if someone in one of your classes tests positive for COVID, you have to stay home for 14 days and attend school via e-learning. That is what all of the schools here are doing, however with my school being a Military Academy, we are affected in other ways as well. We were unable to do Basic Training for new Cadets. We are also unable to march in formation each day. PT has had to be adjusted as well.

Softball has also been affected by COVID, last year our High School season was cut short, our Seniors never got their traditional Seniors Night. Travel Ball tournaments were cancelled for months, some counties are still not allowing tournaments to take place. There are so many new rules now to follow: wear masks, stay six feet apart, wash your hands (well, that's not a new rule, just more enforced now) and at tournaments our families cannot sit together, we cannot shake hands with the opposing team after a game.

It's so much to adjust to, however I'm thankful that we are able to get out and play. Being stuck in our house for months was getting very boring. Not to mention being stuck at home with a little brother!! When you are a kid, even a teenager, all of the rules and restrictions do get tiring. But I do understand that we all need to do our part to keep COVID at bay and keep others safe.

Even with the pandemic going on around us, and many of our events, like Department Convention and Fall Conference, being cancelled, we can all still do our part for our Military families, Veterans and communities, even us Juniors! As President Ann shared in last month's issue, the father of Mr Bill Welser from Honor Flight, had a bad fall and is in a rehab facility up North. His father is a World War II Veteran. Us Juniors could and should shower him with socially distanced love with cards of well wishes. His address is:


#### **Protocol Tips for Members**

- Members have rights and obligations. The right to attend meetings, to make motions, to enter into debates, to nominate and be nominated.
- The Member is obligated to arrive on time for the meeting, and to remain until the meeting is adjourned, except in an emergency.
- Always address the chair before speaking, not other members.
- Be prompt when seconding the motions in order to bring business to the point of discussion. This does not mean you favor the motion.
- Develop the art of listening. Members should be well mannered and attentive at all times.
- One rap of the gavel should bring everyone to instant attention.
- Do not stand waiting for recognition when another has the floor.
- Be seated at once if someone rises to a point of order while speaking on the floor.
- Never interrupt another speaker unless parliamentary law gives that right.

 No member has the right to disturb a meeting by whispering or walking across the floor.



- In speaking, avoid personalities and be brief. Be courteous as well as correct.
- Avoid cliques- they break up organizations.
- Good manners of the members demonstrate a knowledge of protocol.
- Do not sit on your hands when applause is in order.
- Be a contributing member and serve on committees.
- If an assignment is accepted, completed the work as quickly and as capably as possible.
- Cooperate with the elected officers whether they are a personal choice or not.
- Offer friendly assistance to new members, and be loyal to the organization.

#### Conflict Management Getting Along

To be effective and efficient in achieving their goals, American Legion Auxiliary members need to have a shared vision of what they are striving to achieve as well as clear objectives for each program committee. Taken straight from ALA National Support Tools "Conflict Management". We are all here for the same purpose – because we love our country, our veterans, our family and especially that veteran who made it possible for us to put on our American Legion Auxiliary membership pin, raise our right hand and take that oath that makes us members of the greatest organization and largest veteran support organization in the world: The American Legion Auxiliary.

What is our biggest barrier to achieving our goals? **CONFLICT!!!!!!** So, if we're all in it for the same reason - why all the conflict??? Why all the in-fighting? Here's some information from the National website on improving unit relationships - you can print the whole supplement out at: file:///C:/Users/dwals/OneDrive/ Documents/ALA/Leadership/ConflictResolution/ ConflictResolutionAndTeamBuilding.pdf. Printing this out and distributing it to all your unit members to read and work on together is a great team building exercise. And here's my challenge to you!! Do this team building exercise, take pictures and send them and a brief synopsis to me and I will include it in my year end report and future leadership training videos – there might even be a little something for the Unit Leadership Chairman and Unit President. Same challenge goes out to the District Presidents and District Leadership Chairmen let's work together to get our units back on track and working together.

#### Here are some more tidbits and teasers from the

**national tool:** It is important to recognize and resolve conflict among members before conflict becomes a serious problem.

Managing conflict is never easy. Conflict involves members' needs, their perceptions of reality, power, values, feelings and emotions. All members need to have ways of keeping conflict to a minimum. Conflict management is the process of planning to avoid conflict where possible and organizing to resolve conflict as rapidly and smoothly as possible.

"Competition" vs. "Conflict". Competition usually brings out the best in people as they strive to be the best in



their field. Fair and friendly competition can lead to new achievements, inventions or outstanding effort in problem solving.



When competition becomes unfriendly or bitter, conflict can begin, which can bring out the worst in people.

Conflict occurs when two or more people disagree because of differing needs, wants, goals or values. Hurt feelings, anger, bruised egos and poor communication are all precursors of conflict.

#### **Common Causes of Conflict:**

- Different attitudes, values or perceptions
- Disagreements about needs, goals, priorities and interests
- Poor communication
- · Poor or inadequate organizational structure
- Lack of teamwork
- · Lack of clarity in roles and responsibilities
- Desire for power

"Conflict vs, Conversation". Talking about an issue helps address what could possibly just be a misunderstanding or miscommunication. We all have those days where we may be "off our game" we may be a little snippier than usual because we didn't get enough sleep or we're just having a bad day. This could cause our attitude to change drastically and our responses could be a little harsher than we anticipated – Does that ever happen to you?? I know it happens to me - and I'll snap at someone without realizing it. That can have several repercussions – 1. The person who I snapped at will realize that's not my normal demeanor and ask if something's wrong - avoiding a future altercation or 2. The person gets upset and makes a bigger deal of it than needs to be and the snowball rolls down the hill and creates a bigger hullabaloo than needs to be. Which one works better for the benefit of the organization and our mission? "Conversation vs. Conflict".

## UPDATE: The VA Hospitals are now taking donations!!!

- 1. Start by calling the hospital's Volunteer Services.
- 2. You have to make an appointment to drop off donations.
- 3. Please follow the hospitals rules and guidelines.

Now that Florida has lifted some of the restrictions, we can help our Veterans even more! First things first, follow your county's CDC guidelines when dealing with our veterans, and our community. Here are some ideas to bring to your Unit meeting.

- Ask the Legion's permission to host a "Drive-By Donation Day" in the post parking lot. Inform the community that you are taking donations for our veterans. Advertise in the local newspaper; contact the media to see if they will put in their calendar of events on television. Create a Facebook event, create flyers, and post in grocery stores and VA clinics etc.
  - » When the public comes, they drive up to a designated place and pop their trunk! Your Unit members can pull the donations out of the trunk.
  - » Be specific as to what kind of items you need. (toiletries, can goods, books etc.)
  - » Have Auxiliary membership applications handy.
  - » Create a hand out to give to the public on what your Unit does to support veterans, community, and children.
- Contact your local homeless shelter to see if they have any veterans.
  - » Ask what donations you can bring for the veterans.

- » Do those veterans have any children? If so, what can you provide for the children? Do they need clothes, school supplies, food, or snacks?
- » Is the shelter providing meals to these veterans? Offer to bring food, snacks, bedding, clothing etc.
- Contact your local VA clinic to see what needs they may have.
  - » Do they need coffee and donuts? You cannot serve in the clinic but you can have them delivered.
  - » Do they have an outreach program? Can you drop off travel hand sanitizers, handi-wipes etc.
  - » See if you can start dropping off veterans for their appointments.
  - » Each clinic is different! Find out how your Unit, and Members, can help.

As we enter the holiday months, may we be truly thankful for all of our blessings. I hope that you, and your families, stay healthy and safe.



FUNDAMENTALS OF PARLIAMENTARY PROCEDURE

PARLAMENTARIAN SELECTION MA

#### **Basic Parliamentary Principles**

**MARY KELLY-PERKINS** 

Parliamentary procedures exist to facilitate efficiently conducted meetings that protect the rights of members. Fundamental principles of parliamentary procedure:

- Fairness of process and courtesy for all.
- Only one thing, speaker, motion, or action at a time.
- The majority rules.
- The minority must be heard.
- Each proposition is entitled to a full and free debate.
- The purpose is to facilitate action, not to obstruct it.

#### **Common Definitions**

- Parliamentary procedure: Rules by which meetings of
- deliberative assemblies, societies, boards, clubs, etc.,
- are formally conducted.
- Chair: Short form of the word "chairman," used to refer to the member conducting the meeting.
- Gavel: The traditional mallet used by the presiding
- officer to maintain order.
- Quorum: The number of members needed to hold
  a
- meeting as stated in the standing rules of an organization.
- Agenda: A list of the order of business to be considered.
- Minutes: A record of the meeting kept by the secretary.
- The secretary will read the minutes of the last meeting.
- Adjourn: To end a meeting officially.
- Amendment: A specific proposal to modify an
- organization's entity/governance documents.

#### Roles of Those Leading and Attending a Meeting

Roles of those responsible for the process of conducting the business of a meeting:

- 1. Chair: The presiding officer, usually the president (or vice president if president is unavailable), and is responsible for:
- Keeping the meeting on schedule and within time limits.
- Remains neutral by not entering into discussions.
- Expedites the transaction of business by preparing the agenda and keeping order during the meetings.
- States motions that are in order or rule them out of order; asks for discussion, asks for a second to the motion, puts motion to vote, and declares the result of the vote.
- 2. Vice president: Presides in the absence of the president or

whenever the president temporarily vacates the chair (e.g., so she can join a discussion regarding a motion). **3. Parliamentarian:** Appointed by the president, the parliamentarian serves as the expert on parliamentary procedure.

#### Duties of the parliamentarian before a meeting:

Reviews the agenda with the president to be familiar with the business and possible procedural problems that may arise. Reviews and knows the bylaws and standing rules of the organization. Works with committee members who request assistance in preparing reports for the meeting.

**Secretary:** In the absence of president and vice president, the secretary calls the meeting to order and entertains a motion for temporary chairman. The secretary sees that minutes of the meeting are taken – whether taken by herself or her designee – including recording the type of meeting (regular, special, etc.), place, date, hour, presiding officer, all motions and their disposal, names of makers of motions.

**Treasurer:** Custodian of funds of the organization; receives and disburses them upon authority from the organization. The treasurer reports on budget performance and the financial health of the organization to the assembly. If the treasurer is also

an employee of the department, the budget and financial reports should always be prepared and reported by a Finance Committee chair or outside finance

professional.

4. Members: All members whose current membership dues are paid are considered members in good standing and are entitled to all rights and privileges of membership, including those aspiring to and holding office, and voting in the ALA.

• Rise and address the chair if you want to discuss the motion under consideration or to offer another motion.

#### 5. Committees:

Members of committees have no authority except that

which is granted by bylaws or by a vote of the assembly.

- Unless otherwise provided, the member first named to a committee or the one receiving the largest number of votes is the chairman of the committee.
- Members of committees should not conduct business of the committee without a guorum present. A majority of committee members constitutes a quorum unless the assembly orders otherwise.
- Motions and resolutions originating in committees need no seconding, if the committee members are also members of the governing body. The already have been seconded by committee action.

#### **Presenting a Motion**

A proposal for action is made in the form of a motion. For the group to consider a motion, at least two members must be in favor of it.

The first member makes the motion. The second member seconds the motion to show agreement that the motion should come before the assembly. Seconding a motion does not signify that the member is in favor of the motion; she simply wishes the subject to be discussed.

#### There are eight simple steps in presenting a (main) motion:

- 1. The member rises and addresses the chair (chairman)
- 2. The member is recognized by the chair.
- 3. The member states her proposal.
- 4. Another member seconds the motion.
- 5. The motion is restated by the chair.
- 6. The chairman conducts the discussion.
- 7. The chairman puts the question to a vote.
- 8. The chairman announces the results
- 9. Procedure for Presenting an Amendment
- 10. Often, a motion under consideration does not indicate what the group really wants to do. An amendment is how a proposal is changed to get closer to the group's wishes. An amendment can change a motion by striking out, by adding, or by substituting.
- 11. The procedure below is followed when presenting amendments:
- 12. Step 1: The motion is made, seconded, and opened for discussion.
- 13. Step 2: The amendment is made, seconded, and open for
- 14. discussion.
- 15. Step 3: The chairman asks, "Is there further discussion?"
- 16. Step 4: Hearing no objection, the chairman restates the amendment.
- 17. Step 5: The chairman states, "The yes's have it. The amendment is carried, and the motion now reads..."
- 18. Step 6: The chairman then returns to a discussion, or debate, of themotion which is followed by a call for the vote, the vote, and announcement of the results.

### POPPIES RUTH SOVERN

We are now at the beginning of a new year. 2020-2021 is starting out under very different circumstances from the norm. Due to COVID-19 protocols and State mandates, we may need to find new ways to promote a successful Poppy Program and at the same time keep our members and community safe. Stay Strong Florida, we can do it!!

The 2020-2021 Poppy Program is on the Department of Florida website: www.alafl.org There are no changes from the prior year. Our aims and goals remain the same but the reporting dates have been updated. Please send your Unit reports to your District Chairman.

#### 2019-2020 Poppy Program successes:

Fortunately, Covid-19 did not affect our overall numbers for 2019-2020 as they reflected Poppy Distributions in May and November 2019, before all the shutdowns occurred.

The Department of Florida reported eleven of sixteen Districts submitted 2019-2020 Year-End reports reporting activity since the 2019 Yearend reports. Approximately 59,119 poppies were distributed raising \$71,716.16. Most notable: District 6 raised a total of \$20,131.47, District 12, \$10.627.96 and District 7, \$10,145.50.

Based on Department Poppy Contribution reports it appears we only had about 75% of our revenue reported and little more than 50% of the poppies purchased distributed. Imagine if all were reported! Any, and all distributions should be reported, even if donations are not received. The distribution of poppies is as important as the donations collected, if not more important. It means we're spreading the word and keeping their memory alive.

Only one Little Miss Poppy Contest submission was received following guidelines which was submitted to Susan Hall, Southern Division Poppy Chairman June 19th, 2020. The Department of Florida Little Miss Poppy 2020 belongs to Evelyn DeRouin, Orlando Memorial Unit 19. Thank you Evelyn for representing the Department of Florida.

Six posters were submitted for the Poppy Poster Contest, all coming from Unit 286, Pinecastle. One Class II and five Class III and all made by local Girl Scout Troop. All the submissions were awesome making the decision to pick the winner difficult. Unfortunately, we couldn't submit all. The winning Class II and the Class III were forwarded to Susan Hall, Southern Division Poppy Chairman: Class II: Julie Jomer, 5th Grade Class III: Kamryn Kernaghan, 6th Grade

Runners up: Class III, Haley King, 7th Grade, Mia Madrid-Llorente, 6th Grade, Elyse Cherowitz, 7th Grade and Kirra Smithwick, 6th Grade.

Thank you for your participation and representing the Department of Florida.

District Presidents were asked to have their Units design a poppy for the National Poppy Chairman's "Centennial Poppy Project", submitting their District's winning poppy to Department by April 1. Five Poppies were received but only one was actually submitted by a District, all others were sent direct from Units. All submissions were considered and the winning Poppy was submitted by District 5, Kelly J Mixon Unit 9, Jacksonville. The poppy was forwarded to Beth McGinn, National Poppy Chairman on April 27th, 2020. The winner was posted with a photo of the Poppy in the May Mail Call.

Always saving the best for last, this year's Shirley Harbour Award for the best narrative outlining their Poppy Program is awarded to: Pinecastle Memorial Unit 286. Outstanding job Robin Shellhamer and Unit 286!

I wish you success for the 2020-2021 year. There are so many creative members in the Department of Florida I know you will find many new and innovative ways to keep the American Legion






