POPPIES RUTH SOVERN

Welcome to the New Year! As you all know our Poppy distribution was severely impacted by Covid-19 restrictions in the past year but, it's a new year and we need to start planning for a successful year ahead. Let's pray this year will be better than last especially with the Covid-19 vaccine becoming available hopefully, helping us to get back to some kind of normal.

Please remember:

If you plan on Poppy Distributions any day other than Memorial Day and/or Veterans Day, you must send a written request to the **Department President**. An email will suffice.

Poppies should be ordered from Department at least 3 months before your planned distribution.

NATIONAL POPPY DAY is May 28th, 2021. (Always the Friday before Memorial Day).

Year-End Unit reports must be sent to the **District Chairman** in a timely manner for them to be received on, or before, **April 1st, 2021**. If your District doesn't have a Poppy Chairman, send your report to your District President.

Year-End District reports must be sent to the **Department Chairman** in a timely manner for them to be received on, or before, **April 15th, 2021**. If your District doesn't have a Poppy Chairman the District President is required to complete the report.

Poppy Poster Contest and Little Miss Poppy entries should be submitted with Year-End reports. Please follow instructions for submissions to be considered.

DID YOU KNOW??

In accordance with the
American Legion Poppy
Program and poppy fund
rules (revised in 2013 and
2014 by the American Legion
National Executive Committee), poppy funds may be used for the following:

- 1. For the rehabilitation of veterans honorably discharged from the United States Armed Forces after April 6, 1917.
- 2. For the welfare of the families of veterans of the above named period.
- 3. For the rehabilitation of hospitalized military service personnel returning home and awaiting discharge who require treatment in service hospitals.
- 4. For the welfare of veterans, active military personnel, and the families of veterans and active military personnel of the above named period where financial and medical need is evident.
- 5. For the purpose of poppy kits and supplies used to make symbolic poppies and poppy items that will be distributed for donations to the poppy fund.

Poppy funds **CANNOT** be used for the following:

- 1. Any general operating fund of a department, unit, or post.
- Any community service project that does not strictly benefit the welfare of an individual veteran/military servicemember or the welfare of his/her family.
- 3. General maintenance, beautification, or improvement projects of American Legion or Auxiliary facilities, including adding ramp(s) to a post home.
- 4. Investments, even those that would bring profit to the unit or post.
- 5. POW/MIA programs.
- 6. Memberships, including other veteran support

- organizations such as Gold Star Mothers.
- 7. Contributions to, or payouts from, the Auxiliary Emergency Fund.
- 8. ALA Girls State/ALA Girls Nation fees.
- 9. Flags or flagpoles.
- 10. Scholarships which do not restrict eligibility solely to military servicemembers or their children, or where financial need is not evident.
- 11. Mileage, travel, or lodging expenses; registration of conference fees; or costs incurred by a person including ALA members,

- volunteers, and staff to attend any meeting, conference or event, even if is about veterans, military, or any other topic.
- 12. Attire or uniforms use by volunteers or staff in promoting or conducting ALA program activity or business.

I have received questions in reference to 2021 Girls State program and would like to address them in this article.

The 2021 Girls State is scheduled to held in person at FSU on June 9th – June 17th, 2021. At this time FSU has assigned dorms to us. We will follow all CDC and FSU guidelines for COVID during the Girls State program. Currently we do not know what they will be but FSU will provide that information to us when we get closer to time. Any information we receive will be provided to all Units participating in Girls State this year.

Delegate/Alternate registration forms will be going out the 1st of February. There will instructions in each packet for the Unit Girls State Chairman to go over. This year we have a new registration site that is locate on our Department website.

For those who are not aware, when you update your Constitution, Bylaws and Standing Rules, please email them to me first at cbylaws@alafl. org for review. I will respond within 1-2 days with comments of any changes that may need to be made. Once the corrections are made, then you

MUST mail two complete sets with original signatures to my home address, 3270 Heider Road, Titusville, FL 32796-1557, for approval.

After they are again reviewed and approved, I will return one set to you for your files and will send the other set to Dept. HQ for their files.

Now is the time to update your Standing Rules if you are considering increasing your dues. Any dues increases must be finalized and a copy of your approved governing documents on file at Dept. office before April 1 so when you complete the 2022 Unit dues information sheet for Dept., they match your Standing Rules.

PARLIAMENTARIAN

MARY KELLY-PERKINS

As you know The American Legion Department of Florida had cancelled the 2020 Department Convention.

The following is information that was received from National Executive Director, Kelli Circle, in the NEC briefing dated April 10, 2020.

"The national organization does not have authority to determine whether departments hold their conventions. As the American Legion NEC has stated we too strongly urge all American Legion departments follow a similar course of action, towit: (1) cancel their 2020 conventions and elections; and (2) maintain the status quo of their officers until next year. This is a recommendation not a mandate."

I know that you are probably wondering why this is being addressed again and the answer is that members have been inquiring about endorsements for District Presidents and they are confused with the term limits.

In April 2020, a letter was sent to the Auxiliary Executive Committee to cancel Convention due to COVID-19 Pandemic. The Executive Committee voted to cancel Convention and to keep all elected Department Officers which would include District Presidents.

Our Governing Documents aka Constitution and Bylaws (Article VII Sec Sec 2 page 35

in Unit Guide) states a District President shall not be eligible for the same office for more than two terms in SUCCESSION.

After researching our Department Governing Documents and Roberts's Rules of Order here is the simple answer which I think you will understand.

If a member was elected to serve as District President for the year 2019-20 and she DID NOT serve for the 2018-19 year, then her actual first year term was 2019 to 2021 and she CAN be endorsed as a candidate and be elected for the 2021-22 Auxiliary year...

If the member did serve as District President in 2018-19 and again 2019-2021 (Due to Pandemic) then she CANNOT be endorsed or re-elected for the 2021-22 year.






