First, I want to send Thoughts and Prayers to Everyone Dealing with the Historic Disaster, Hurricane Irma. I understand electricity is just coming back for several locations, collections and deliveries of water, food and other greatly needed supplies are continuing for the greatly devastated areas and the daunting task of cleanup and debris removal has just begun.

The American Legion Family is working together to assist those in need! Department Commander Steve and Detachment Commander Bernie drove their loaded trucks and trailers of collected goods from Orlando, Titusville and Lake Wales to Homestead and from there to Marathon. They traveled to Baby's Coffee (Mile Marker 15) and shared on Facebook the photos showing the aftermath devastation of destroyed vegetation, damaged buildings, overturned trailers and RVs, displaced boats and sunken yachts.

Other Posts have also collected items and delivered to the "Distribution Posts" reaching out to families hit hard. Labelle organized a hot meal smorgasbord for the Utility Crew sent to repair the power. Department of Alabama and North Carolina have reached out to donate towards both Texas and Florida AEF. Tractor Trailers of supplies have come as far as Maine and Indianapolis to support the relief effort.

I know many more of you are assisting with relief efforts within your communities. Our neighbors gathered to replace fences, repair roofs, cut and clear fallen trees and raked debris. Then we had a celebration (albeit sweaty) of job well done together! National has contacted me requested stories and photos of how our Auxiliary Units and Members are working together volunteering to assist others, preparing for and during the storm as well as in its aftermath. Please send your stories and photos to Patty, our Department Secretary, so we can compile a journal to share.

Needless to say, the weather has whipped our schedule all around. It just means we will look forward to rescheduled postponed activities when they happen! As Department Workshop will be completed by the time you read this, please attend the upcoming Schools of Instruction in your Districts. In the aftermath of Hurricane Irma, there have been many acts of kindness and heroism from our American Legion Auxiliary members as we huddled together to protect our family, friends and neighbors prior to the storm. After the storm we provided shelter, rescued some from their homes by boat, checked on the elderly, distributed food and water, assisted each other with cleanup and continue to help others.

American Legion Auxiliary members selflessly serve veterans and military families. But when the need strikes home the Auxiliary Emergency Fund is available to eligible members for temporary emergency assistance when no other source of aid is readily available to pay for shelter, food and utilities. Members with 3 consecutive years of paid membership are eligible to apply. Applications are available at alafl.org, go to the program tab and scroll to the Emergency Fund.

When a disaster hits, we see firsthand the devastation it can bring. We can continue to help our members by considering a donation to the American Legion Auxiliary Emergency Fund. Greetings from Department of Florida Headquarters! I would like to start off by saying the Department Staff is sending prayers to you and your families. If you have received damage or a hardship from Hurricane Irma, please remember we have the Department Auxiliary Emergency Fund that you can apply for. If you are interested please go to www.alafl.org.

I would like to cover a few items about membership in my article. I have received calls asking when the renewal notices will be going out. National has already emailed the first renewal and the printer for National has mailed the first notice as of September 15th, 2017.

When sending in membership, please make sure you are putting the correct year on the recap sheet. Please list only one year. For example if you are paying 2016-2017, dues only write 2017. If you are paying 2017-2018, dues only write 2018.

Please submit one check per membership recap sheet. This is very important for the over and short report! At this time if Department receives one check for more than one recap sheet, we will be returning it to the unit with a memo stating why it is being sent back.

When submitting new membership applications, make sure you review them completely before sending them in. If information is missing, we will have to send it back with a memo. Also, make sure that the Post Adjutant has signed the application.

When completing the membership recap sheet, make sure the names are in alphabetical order starting with the last name. If we received a recap sheet that is incorrect we will send you a memo the first time. After that we will be sending the recap sheet back along with the unit check asking for it to be completed correctly.

This year I have the privilege of talking Protocol. We all want to do a good job and there are many questions and concerns about doing the right thing at the right time. The ALA National headquarters has provided us with many great resources available to ALL members. The below information can be found in National's Unit Guide Book and Department Operations Guide located at www. alaforveterans.org/members/guides/

Each article this year I will highlight some of the most common ALA protocols/customs. If there is a particular topic you would like me to cover please email me and I will be sure to address it.

What is protocol ...

The American Legion Auxiliary, like most companies and organizations, has required procedures. These customs for conduct at meetings, events, and official ALA social gatherings are based on traditions and historical practices and have become known as ALA protocols and ALA etiquette.

New members and ALA guests alike are often intimidated or feel excluded because they are not familiar with the ALA's customs for etiquette at ALA meetings and events. It is important to know that customs and protocols are not lawful requirements. Members and guests who do not abide by the ALA's many customs are not violating laws and should not be made to feel belittled or demeaned for being unaware of ALA customs. The following information is to help Districts, Units and Members understand common ALA customs and to follow customary ALA etiquette. Below are just a few of the most common ALA protocols or customs. There may be other customary practices unique to individual Districts or Units. The following norms/customs, while not legally required or established, are longstanding practices of the American Legion Auxiliary The Emblem, Ribbons, and Pins:

▶ The emblem should always be accorded the place of honor at any meeting. It not only represents the organization; it "is" the organization, the American Legion Auxiliary, and acts as the signature of the organization.

▶ Use of the emblem must receive the approval of the national secretary.

➤ The wearing of cross-body ribbon sashes are longstanding customs in the organization since its founding. The sash ribbon is worn by various officers on all levels, present and past. The sash ribbon is worn on formal occasions and never over a topcoat of any kind, but may be worn over a suit coat. The ribbon is worn over the right shoulder and under the left arm. No pins or decorations should be affixed to the ribbon. It should not be knotted at the left to fasten it, but should hang crossed and secured by an invisible fastening on the underside.

▶ Members are encouraged to wear the pin of the current office in which they are serving or have just completed, or the highest office held by the member. It should be worn on the left side, over the heart.

Some Units still continue a tradition of wearing corsages at certain events. If a corsage is being worn, it should be on the left side, above the Auxiliary pin; a corsage is customarily considered a part of the dress once it is pinned in place.

▶ Members are encouraged to wear the pin of the current office in which they are serving or have just completed, or the highest office held by the member. It should be worn on the left side, over the heart.

Some Units still continue a tradition of wearing corsages at certain events. If a corsage is being worn, it should be on the left side, above the Auxiliary pin; a corsage is customarily considered a part of the dress once it is pinned in place.

> If a flag pin should be worn, it should be worn on the left side of the blouse and may be worn with the pin of the current ALA office held by the member. The flag pin should be placed above the ALA pin(s).

#### Escorting Guests to the Podium:

When escorting a Legionnaire to the podium for the purpose of introduction, greeting, or an address, the correct procedure is for the ALA escort to take the Legionnaire's left arm, with the Legionnaire on the escort's right, thus freeing the Legionnaire's right hand for the purpose of saluting the colors prior to advancing on the dais. Be sure to pause before the colors to allow time for this salute.

This same escorting process is to be used when escorting other guests, (ladies and gentlemen) and ALA members, with the pause to salute the colors.

There are some ALA members, who appropriately pause and place their hand over their hearts, rendering the civilian salute to the colors. Federal law allows veterans to render the military right hand salute, even dressed as a civilian. The key factor is not how the salute is rendered, but that an appropriate salute is rendered.

#### Salute to Colors

The American Legion National Headquarters has advised the following on this matter. The Post Officer's Guide and Manual of Ceremonies asks that those Legionnaires who are entering or exiting a meeting salute the "station of the Commander." An acceptable protocol for those who approach the podium is to also properly salute the colors. The national organization appreciates the demonstration of patriotism and respect given the colors by our ALA members when they have stopped and saluted. "Breaking Colors" or "Cutting the Flags"

Many departments and units observe a custom that is fairly unique to the American Legion Auxiliary that deems it disrespectful to "Breaking Colors" or "Cutting the Flags". Many ALA members expect other members to respect the "colors of the ALA or Legion," that is to say, respect the posted flags at the front of a room, stage, or meeting by not walking in between the flags.

While it is a custom of respect observed by many in the Legion Family to not "break/cut" between the flag and podium or another flag also posted, there is nothing in the U.S. Flag Code that addresses "Cutting the Colors" when flags are posted in the front of a room.

Protocol is what to do in a given situtaion. Etiquette is how to do it – and how to do it gracefully.

In addition to this assistance, other types of financial assistance are available for utilities, shelter and food through the National and Department AEF programs. You may find information on these programs and the applications by going to our website at www.alafl. org/programs/emergency-fund and the link for the Department, National and **AEF Expedited Applications** are posted there. Information on eligibility, grants amounts and where to send the applications are available on each form.

Looking for ways to help? **Donations for Department AEF are welcomed and needed!** We anticipate many applications in the coming weeks. We want to be able to help as many members as we can so your help is vital! Please go to our website at <u>www.alafl.org/donate</u> to donate to our AEF fund by credit card. Donations may also be made by check or money order mailed to ALA Department of Florida at 1912A Lee Rd Orlando FL 32810. Please notate <u>"AEF Disaster Relief"</u> in the memo line. Units can donate to this program through the regular donation remittance form process found on the website under Forms & Resources- Unit Forms. We do have some regular back-to-business items to address:

1- MCR- Membership Credit Report. The first membership credit report of the new fiscal year was scheduled to go out at the first of October, and was to include September's activity but, due to Hurricane Irma, we now have Workshop re-scheduled to September 29-30 so plans have been changed. So, I sent the MCR's out with July & August activity only. These were mailed with the Quotas. Know that I will do my best to the monthly October report out as close to the 15th as possible, but please be patient. When you receive your report, please contact us immediately if anything is incorrect. Also, remember to use any available credits with your next membership transmittal. A complete guide to understanding your MCR and FAQ's is listed on page

2- Quotas. Invoices were sent to your Unit between September 22-September 26. Please remit the monies ASAP to Department as quotas are vital to the essential programs of this organization.

3- Donation Remittance Form. The new 2017-2018 donation remittance form has been updated on the website. Go to www.alafl.org/quicklinks/forms-resources and it is under "Unit Forms". Use this to send in any donations to programs listed, throughout the year. Please remember that ALL donations must be received by 04/30/2018 in order to be eligible for awards in the 2017-2018 fiscal year.

4- Monthly Contribution/Donation Reports. Monthly contribution reports will be listed on the website beginning October 1st. We will list all donations received May 1, 2017 to date that count toward the new fiscal year awards.

#### IN THE EVENT OF A DISASTER Are you prepared to help your community?

Hurricane Harvey has decimated Houston and parts of Louisiana. It could have been us! Since we are still in hurricane season, it makes sense to sign up now for a CERT class so you'll be ready! Please consider taking this important class.

The Community Emergency Response Team (CERT) program, underwritten by FEMA, helps train people to respond to emergency situations in their communities. When the unexpected happens, CERT members can give critical support to first responders, provide immediate assistance to victims, and organize volunteers at a disaster site on the spur of the moment.

CERT members can also aid non-emergency projects to help improve the overall safety of the community.

The 2,700 local CERT programs nationwide have trained more than 600,000 individuals just like YOU.

Classes are FREE and require approximately 24 hours over approximately 8 weeks. Most classes are held on nights and/or weekends to accommodate work schedules.

#### Greetings,

First, I would like to say that I am honored and excited to be your 2017-2018 Department Education Chairman.

As school began Units were busy collecting schools supplies and distributing to the schools in their area. Some Districts and Units sent me some of their activities that they did to support the "Give 10 to Education"

District 6, Unit 80, St. Cloud, collected schools supplies and distributed them to SSVF (Supportive Services for Veterans Families) supplying 36 students with school supplies, they were also able to help members from Unit 80 with school supplies and uniforms, and are continuing to collect supplies for local schools. Unit 286, Pine Castle, collected school supplies and backpacks. They then had 15 Legion Family Members sort and stuff 119 backpacks for a Back to School Party for students in VPK all the way through high school. At the party, they served food and played games with the families attending. Junior Members Jasmine and Analyssa and SAL member Jake helped run the games

• District 16, Unit 275, Dunedin, developed a partnership with Walmart Store#2801 in Clearwater, thanks to one of their unit members Kim Oubre who is an associate there. She is also the Unit's Education Chairman. Kim works closely with her Managers and Claims Associates and is always willing to accept donations that will be utilized

by the Legion Family. They were able to collect two truckloads of school supply donations, everything from binders to rulers including almost 600 pencil boxes. The distribute school supplies to 3 elementary schools in Dunedin and 1 school in another district. They may be able to assist victims of Hurricane Irma if needed. District 16 also teamed up with The Pinellas County Council PTA and set up a Legion Family booth at their PTA Leadership Workshop, a mandatory workshop held for all K-12 School Principals and staff. There were over 200 vendors at the workshop. All four entities of the Legion Family helped with this event. Way to go District 16!! We may want to continue to collect school supplies to help replenish schools with supplies that were lost during Hurricane Irma. I know that there are schools out there that have already mentioned the need. Our next major event for Education is American Education Week, November 13-17th, 2017. This is a time when we honor the individuals who are making schools great for every child. This week is not only dedicated to teachers but also the office staff, custodial staff, principals, bus drivers and school board. I have listed below just a couple of ideas, but for additional ideas you

• Gift Basket of goodies (candy, cookies, any baked goods) for all

personnel at the school, along with thank you cards)

• Have your Juniors make thank you cards for bus drivers and give them to the bus driver when they get on the bus. Juniors can also make thank you cards for teachers and other support staff.

• Provide a breakfast for the staff and teachers (doughnuts are always welcome.)

• Take muffins/doughnuts/other baked goods to the local School Board. Don't forget to promote our Scholarships. Please check for the deadlines on alafl.org and alaforveterans.org Mid-year reports are due soon.

• Unit Reports—to District Chairman: November 15, 2017.

• District Mid-Year Reports Due to Department Chairman: December 1, 2017

When sending in your reports please send in a narrative along with pictures of your activities.

#### FAQ about the Membership Credit Process

Please "square up" your account at the end of each month based on this report. Due to new rules from National, we may be unable to correct any error that is not discovered and reported within 90 days of original transaction.

Why is our Unit not getting checks anymore for our online renewals?

As of 2017, Department will no longer be sending a check when your unit member pays online. Instead, you will see the credit on your newly re-formatted membership credit report (previously called over/short report). The transaction's entry line will read "Online Renw" or "OR" (with a date) and the memo line will have the member's full name and membership number. See Example Below:

Do I have to wait on the membership credit report to issue the member's cards/use the credit?

No. If you have ALAMIS access, you can go to the Unit section of the page (along the top next to Task Center)-Unit reports- Unit Dues Paid Online- and use that as proof of payment to issue your membership card to your member. You can also print and send that form in to Department and write "Online Renewal Credit" on it, if you want to use the credit before we have issued it to your Unit in the membership credit report. Your credit will be your unit's portion of dues. You can also accept the member's receipt as proof of payment and send a copy of the receipt to Department if you wish to use the credit immediately.

How do I use my online renewal credits?

At the end of the report, there is a "Net Income" line, a positive number reflects your total credits. You may use that credit on membership transmittal(s) to Department. On the "Membership Recap Sheet" report you send us, there is a line that says "Credit Used", simply write the amount of the credit that you are using to pay for that transmittal and write the letters "MCR" for "Membership Credit Report" next to it. If the credit you have is less than what you owe for that transmittal, simply subtract the amount of credit from what you owe and send a check for the difference.

What are the "Over/Shorts" part of the credit report? How do I know why this was credit was issued?

Department sends a "membership memo" with detailed information each time there is an actual overage or shortage on your membership account. If you use a number system when you submit your transmittal, and one was available when we processed your membership, we will reference that number in the memo line of the report. Over/shorts from a transmittal will have a "T" for transmittal with a # next to it. Reference your transmittal for those items. If you do not use transmittal numbers or one is not listed, our "Recap" number should be listed. This is a 3 digit number followed by the year. For example, 123-2018. If you have a question about a particular line item that has our "Recap" number, simply email membership@alafl.rg with the Recap number with your inquiry and we will research your issue using this information.

How do I read my membership credit report?

This report is from our accounting software. The line items within the report are shown within an expense account which means that a negative number is a CREDIT/OVERAGE and a positive number is a SHORTAGE to Department. The FINAL totaled line showing your grand total of all line items is labeled "Net Income" and is shown within an income account, so the number shown there is positive if a credit and a negative if a balance is owed to Dept.

Why do I have transactions on my report when I have not received a membership memo?

When you send in one check for multiple transmittals, you will end up with more overages and shortages because we can only process the check with one transmittal. The net total will balance out to zero so you do not receive a memo, but the transmittals will be listed separately and show as over/shorts within the report.

For example, you send one check for Transmittals 1, 2 and 3 and the check total is \$115.50 for 7 members.

Transmittal 1 has 5 members. This transmittal will show an overage of \$33.00

Transmittal 2 and 3 have 1 member each. These transmittals will show as a shortage of \$16.50 each.

The net total will balance out to zero. T1 \$33.00 over - T2 -\$16.50 short - T3 -\$16.50 short= \$0

NOTE: THIS IS WHY THE NEW ONE CHECK PER TRANSMITTAL POLICY IS IN PLACE

What if we have a membership credit balance at the end of the fiscal year?

When we close our membership books for the fiscal year, (our FY is July 1- June 30) we will send you a check if you have an outstanding credit, or an invoice if you have an outstanding balance to close out the account for the fiscal year.

Can I receive my membership credit report quicker via email instead of "snail mail"?

Absolutely! You will be among the first to receive your report as emailed reports go out first!! If your preference is to receive this report via email, please send an email from the email address you wish to receive your report at, to bookkeeper@alafl.org and write "Email my Membership Credit Report" in the subject line. Please include your name and Unit # in the email!

# **IT HAPPENED IN RENO!!!**

Dr. Sue Sisley, working in collaboration with the National Institute of Health and National Institute on Drug Abuse is conducting a study at the Scottsdale Research Institute in Phoenix, Arizona. She asked for the Legion's support for her research during the 2017 American Legion National Convention in Reno. Supporting this study falls within the scope of the (Legion's Resolution 11) passed a year ago.

The research being conducted by the Scottsdale Institute is the first cannabis study of its' kind in the U.S. This could produce evidence that will enhance, improve and save lives of veterans suffering with post-traumatic stress disorder and traumatic brain-injury, along with other diseases and disorders.

The American Legion Family continues to urge our federal government to support and enable research to confirm the medicinal value of cannabis. As the largest veteran based service organization in the world, it is our duty to advocate improving the health of our veterans, specifically service-disabled.

On September 20, 2017, The American Legion National Commander Denise Rohan sent a letter to the Department of Veterans Affairs Secretary, David Shulkin urging him and the department to support the vital FDA Marijuana/PTSD research study at the Scottsdale Research Institute. Contact your Senators and House of Representatives to support cannabis research for PTSD and TBI sufferers.





## From the Finance Chairman

#### File your 990-N, 990 EZ or 990 on or before November 15

If you have \$50,000 or less in gross receipts (most Units fall under this category), you have until November 15 to file your 990-N for the fiscal year July 1, 2016 – June 30, 2017 (tax filing year 2016) providing you are compliant with National and Department by operating with a fiscal year of July 1 – June 30. If it is not your fiscal year, we strongly urge you to correct it.

Note when registering or filing: Text fields cannot exceed 35 characters and must contain only numeric, alpha or hyphen characters unless noted otherwise. Periods, slashes, etc. will cause registration or filing errors. Browser issues: If you have multiple browsers open when registering or filing, errors may occur. Using Google has created problems for Units in the past so please select a different browser.

If you are filing a Form 990-N for the first time as a new treasurer and the account has already been set up, proceed with the following;

- 1. Go to https://sa.www4.irs.gov/epostcardsecure/ home/
- On the right side of the window, select "Manage Form 990-N Submission" to create a new Form 990-N electronic filing submission.
- From the drop down window, select "Exempt Organization" in the "User type" field. Click "Continue"
- Enter the 9 digit EIN, Taxpayer Identification #, for your Unit and then click "Add EIN". To continue, select "Create New Filing"
- Select the EIN you wish to file for from the drop down menu. Once you have selected the EIN (it should be your Unit's EIN), select "Continue".
- 6. Complete the "Organization Details" page.
  - a. Insert the fiscal year ending 6/30 in the first field (if your Unit is compliant with National and Department by having a fiscal year of 7/1-6/30. If not, you will need to correct it).

b. Enter Yes or No in the field asking if your organization has terminated or gone out of business.

- c. Answer Yes to "Are your gross receipts normally \$50,000 or less". If your gross receipts are more than \$50,000, you will not be able to file the 990-N form.
- d. When you have completed each line, select 'Continue".
- Complete the "Contact Information" page. Be sure to enter American Legion Auxiliary in the field "Organization's legal name". Also be sure to enter the rest of your Unit's legal name in the "DBA Name" field. When you have completed each line, select one of the following:
  - a. **Save Filing**: Select if you are missing any requested information. This will allow you to return to complete it later.
  - b. **Submit Filing**: Select when you are sure all required information has been input.
- 8. The filing "Confirmation" will display the filing status as "Pending." Click on the word "Print" in the bottom paragraph to print a copy for your records. Once you leave the page, you won't be able to print this filing.
- 9. Remember, if you miss filing by November 15 for a specific year, you will not be able to go back and file for that year. If 3 years are not filed consecutively, you will lose your tax-exempt status.
- On the "Manage Form 990-N Submissions" page, your submission will show the status as "Pending".
  - After 7 minutes, refresh the page (F5 key for Windows; Command-R for Mac) and the "Get updated Status" button will be visible.
  - b. Select "Get Update Status" to see if your submission was accepted or rejected.
  - c. If your submission was rejected, select the submission ID hyperlink for additional details.

#### To file Form 990-N for the first time

- 1. Go to <u>https://sa.www4.irs.gov/epostcardsecure/</u><u>home/</u>
- 2. Click "Get Started"
- 3. Fill in your first and last name and e-mail address
- 4. Click "Send E-mail Confirmation Code"
- 5. Check your email for the "Code"
- 6. Enter the Code and click continue
- Be sure to write down the information you enter so it can be passed on to the next treasurer. You will need to provide the following information.
  - a. User name: (Suggestion only) <u>TreasurerUnit</u> (insert your Unit #) No spaces allowed.
  - b. Password: \_\_\_\_\_(Only letters, numbers, ! or #)
  - c. Phrase: \_\_\_\_\_(I used "For God & Country")
  - d. Site image. Select one and make a note of it for future use.
  - e. Select 4 security questions and provide the answers. I would recommend not using or answering with personal information but rather Unit related information.

You will then select the button to enter your 9 digit EIN (same as TIN) and will be able to file your 990-N return.

When you are filing the E-Postcard, you will see the name American Legion Auxiliary. Be sure to enter the name of your Unit on the second line (doing business as).

Example: American Legion Auxiliary and in DBA field "Titusville Unit 1, Inc.".

If you have difficulty with your information being retained, try using a different browser. Google does not seem to work. Alternatively, you can file a **990-EZ** if you have gross receipts less than \$200,000 and total assets of less than \$500,000. However, if you elect to file a 990-EZ, you will have to maintain complete records of member and non-member income. "All organizations filing Form 990-EZ must complete Parts 1 through V and any required schedule." You can file electronically.

Note: If you host bingo games and have gross revenue (amounts collected before payouts) over \$15,000, you will need to complete a Schedule G also.

Most Units will not be required to file a 990. However, if you meet the requirements of 'either gross receipts greater than or equal to \$200,000 or total assets greater than or equal to \$500,000 at end of tax year, I strongly advise having a CPA prepare it for you as it is significantly more complex.

### Remember to send a copy of your filing to the ALA Dept. of FL for our records.


