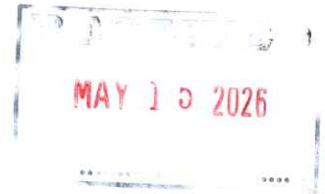


ROBERT BETHEL ALA STANDING RULES

1. THE REGULAR SCHEDULED MEETING OF THE ROBERT BETHEL ALA UNIT 220
Shall be held on the fourth Saturday unless otherwise specified and shall be called to order at 10;00am.
Executive Board meeting shall be held as needed and on an emergency basis by President--- to be notified by phone,email,or other electronic means at least 24hrs notice
All decisions must be bought by to Unit.
2. Three members of this Unit shall constitute a quorum at any regular scheduled meeting of the Unit.
3. The annual senior members dues of the Unit shall be \$50.00 to include Department and National per capita The annual dues of the junior members shall be \$10.00 to include National and Department per capita.
4. In addition to Core Committees listed in the Bylaws,the Unit shall have the following Committees; Auxiliary Emergency Fund (AEF0),Community Service,Education.Girls State Junior Activites,Leadership,Legislative,Past President Parley,Poppy,Public Relations,VA/R Children and Youth.

Unit elected officers shall consist of ; President, Vice President Secretary, Treasurer Chaplain, Sgt@arms, Executive Board members (4) Historian, Parliamentarian appointed by President.

Treasurer responsibility to sign and disburse funds – Must have Two signatures on checks.

All members responsible for Unit funds shall be bonded through blanket Fidelity bond and unit shall pay annual premium to Department headquarters.

A Budget committee shall consist of (3) Members including treasurer to be appointed by Present for the purpose of presenting a budget for the ensuring year.

A nominating committee consisting of three members shall be elected to present a slate of officers for the purpose presenting candidates for the ensuring year

Permission from each candidate for each office This committee must form no later than two weeks to election.

Unit President may be authorize to receive \$150.00 in discretionary funds as needed with the approval of Unit.

Unit Delegates to annual Department Convention shall receive \$50.00.

The allotted amount for Bereavement acknowledgements (FLOWERS and MONETARY) Shall not exceed (\$100.00). to be given to spouse.

Voting may be done in person by ballot and other electronic method, Must be received by nomination committee with (7) seven days of transmittal to body.

Unit meetings may be in person and by electronic means and emergency situations Executive Board meetings may be done in person and by electronic means.

All transfers to Unit must be voted on by Body

All new members must processed by membership chairperson for eligibility.

These ByLaws shall be amended to conform to National and Department Constitution and ByLaws and Standing Rules of the American Legion Auxiliary. Automatically.
