

## STANDING RULES

1. The regular scheduled meeting of American Legion Auxiliary BAREFOOT BAY Unit #366, Inc. shall be held on 3<sup>RD</sup> TUESDAY of each month, unless otherwise specified and shall be called to order at 1:00 PM. An Executive Committee meeting shall be held the 2<sup>ND</sup> THURSDAY of the month and shall be called to order at 2:00 PM unless otherwise specified.

2. (10) TEN members of this Unit shall constitute a quorum at any regular scheduled meeting of the Unit.

3. The annual Senior membership dues of the Unit shall be \$35.00 to include Department and National per capita. The annual dues of the Junior membership shall be \$ 4.25 to include the Department and National per capita.

4. In addition to the Core Committees listed in the Bylaws, the Unit shall have the following Committees: Auxiliary Emergency Fund (AEF), Community Service, Education, Girls State, Cavalcade of Memories, Junior Activities, Leadership, Legislative, Past Presidents Parley, Poppy, and Public Relations.

5. Unit elected Officers, consisting TREASURER, SECRETARY, PRESIDENT are authorized to sign checks for disbursement of funds from the Unit treasury. All checks MUST have two of the three above signatures.

6. All members responsible for Unit funds shall be bonded through the blanket Fidelity bond and the Unit will pay the annual premium to Department Headquarters.

7. Where deemed necessary, a Recording Secretary and a Corresponding Secretary may be elected/appointed to carry on the duties normally performed by the Secretary.

8. A Budget Committee composed of three (3) members, including the Unit Treasurer, shall be elected by the members, or appointed by the President, for the purpose of presenting a budget for the ensuing year.

9. A Nominating Committee, composed of three (3) members, shall be elected by the members for the purpose of presenting a slate of officers for the ensuing year. The committee shall have the permission of each candidate for an office in order to be presented by this committee. This committee is to form no later than two (2) months prior to election.

10. The Unit shall be guided by the Code of Ethics as published in the National Auxiliary Standing Rules on Pages 23-27.

11. Unit meetings may be held in person or in emergency situations, via electronic means. Voting may be by voice ballot, email or other electronic means.

12. Due to our Unit being a Seasonal Unit, members in good standing, that wish to vote in our election, when out of town or sick, may vote by the following means: Written vote, electronic vote by text and / or email.
